**Sub: Agreement with M/s. MSTC Limited on e-forward auction services.**

Sir/ Madam,

Central Warehousing Corporation (CWC) has signed an agreement on 10.09.2018 with M/s. MSTC Limited (a Mini Ratna, Category-I PSU under Ministry of Steel, Govt. of India) for availing forward e-auction services, which shall not only bring transparency and efficiency but will also save manpower cost in processing the tenders. The unique features of M/s. MSTC's Ltd.'s e-auction platform will avoid repeated tender, lower the tender processing cost and increase process efficiency. As part of agreement, M/s. MSTC Ltd. shall also undertake digital marketing which has the potential to reach customer across the globe.

Presently CWC allocates various types of warehouses on rent, which are offered on first-cum-first-serve basis thereby having a constraint to reach optimum value. With usage of transparent and efficient e-auction services, the customer reach shall improve which will directly enhance the utilization of warehousing space and increase the profitability.

The services charges for availing e-forward auction are as follows :

- (i) 1% on the total contract value for leasing/ renting of properties/ warehousing spaces.
- (ii) 1.75% on the value of materials disposed for confiscated & time barred goods in Customs area.
- (iii) 2.5% on the value of materials disposed for all other type of good.

The service charges needs to be paid only on successful completion of e-auctioning process including contract and realization of security deposit by CWC.
