#### **CIRCULAR**

Subject: Amendments in Model Tender document of ELWB - reg.

Reference: RO, Jaipur letter No.CWC/JPR-IV/New ELWB/2017-18/5634 Dated 08.01.2018 and 5670 dated 09.01.2018 and clarifications thereon vide letter No. CWC/ JPR /LWB/2017-18/6622 dated 13.02.2018

We have received a reference from Regional Manager, Jaipur regarding certain modifications/amendments in the Model Tender Document of Electronic Lorry Weigh Bridge being procured by Regional Offices. The suggestions of Regional Manager, Jaipur have been examined and the decision of Competent Authority on these suggestions are as under:-

#### 1) Section -V, clause No.28.1:

Following para should please be added under section V, clause .28.1 "For installation of ELWB, the site plan is available in the warehouses. The tenderer may visit the site before submission of tender for his understaning about the site plan and conditions.

#### 2) Clause 15.2 Ramp and approach Road:

Following nomenclature should be inserted under clause 15.2 "The Ramp should be provided with steel fender of section 100x100x8 mm on both sides of complete length of ramp and should be fixed in cement concrete of ramp with 12 mm dia & 30 cm long bolts at a distance of 30 cm centre to centre with or without connecting plate including cutting, hosting, fixing in positionand applying coat of approved steel primer complete."

#### 3) Clause 15.3 Cabin:

- 1. Following nomenclature should be inserted in clause 15.3 "along with providing and laying brick tiles over roof grouted with cement and mortar 1:3 (1 Cement: 3 fine sand) mixed with 2% of integral water proofing compound by weight of cement over 12 mm layer of cement mortar 1:3 (1 Cement: 3 fine sand) and finished neat."
  - (ii) Following nomenclature should also be inserted in clause 15.3 "Making plinth protection 50 mm thick of cement concrete 1:3:6 (1 Cement :3 Course Sand : 6 graded stone aggregate 20 mm nominal size) over 75 mm thick bed of dry brick ballast 40 mm nominal size) well rammed and consolidated and grouted with fine sand including finishing the top smooth 0.90 meter wide along with tha cabin walls.

### 4) Section-V, Clause No. 41(3) Period of Guarantee:

Guarantee period of should be increaseed from twelve months to two (02) years.

5) Section-VIII, clause (4) 4.2(6):

Regarding handing over of product key for the software as well as operating system for calibration and maintenance to Warehouse Manager and also to Regional Office, the product key is the intellectual property of the bidder and the bidder does not manufacture the ELWB for CWC only but for general public, hence the tenderer may not agree to handover the product key for software as well as operating system. In case, the said condition is inserted in the tender document and the tenderer does not accept the condition, the tender shall be conditional which can not be accepted. Hence it may cause the delay in completion of work. Therefore existing clause should continue.

In view of above, it is requested to make necessary modifications/ amendments in the Model Tender Document of ELWB as at Point No. 1, 2, 3 & 4 above, as approved by Competent Authority.
