As you would be aware, Government e-Marketplace is the National Public Procurement Portal offering an online, end-to-end solution for procurement of common use goods and services by Government Departments. It is used by Central and State Government Ministries/Departments, Central & State Public Sector Undertakings (CPSUs & SPSUs), autonomous institutions and local bodies. GeM provides an open, inclusive, transparent and efficient online marketplace, providing huge savings to government. In this regard, a copy of D.O. letter dated 20.08.18 from Secretary Commerce is also enclosed.

2. The detailed note on the Mission as shared by GeM lists, the following set of key objectives aimed at enhancing use and adoption of GeM for procurement of goods and services:

- (i) Promoting inclusiveness - by catapulting various categories of sellers and service providers e.g. MSEs, Start-ups.
- (ii) Highlighting transparency and efficiency - by highlighting 'value add' through transparency in public procurement including corruption free governance.
- (iii) Achieving cashless, contactless & paperless transactions - achieve these lines with Digital India objectives.
- (iv) Leading to significant cost saving - by increasing overall efficiency leading to savings on government expenditure in procurement.
- (v) Maximizing ease in availability - by conducting registration drives for existing vendors of buyers to further expand the base of products, services and vendors on the platform.

3. I request you to kindly notify a nodal team that ensures implementation of the Mission in its true spirit and achieves milestones as listed for the Mission.


