Subject: Amendment to Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 Implementation – reg.

Sir,

As you may be aware that Ministry of Micro, Small and Medium Enterprises (MSME) Government of India has notified Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 which mandates 20% of annual procurement by Central Ministries/ Departments and CPSEs from MSEs including 4% from MSEs owned by SC/ST entrepreneurs. This policy become mandatory w.e.f. 01.04.2015. This has earlier been informed vide this office letter No. CWC/Pur./S&P/MSME/2015-16/411D dated 08.01.2016.

Vide Ministry of MSME, Govt. of India letter No.F.No.21(8)/2018-MA dated 09.11.2018 and Ministry of Heavy Industries & Public Enterprises, DPE Office Memorandum No.DPE-7(4)/2007-Fin dated 08.01.2019, following amendments have been informed:

- To increase in the percentage procurement of goods and services by Government Departments/ CPSEs from MSEs from the present at least 20% to at least 25% of total procurement including a sub target of 5% procurement from MSEs owned by SC/ST entrepreneurs.
- To provide for a minimum 3% reservation for women owned MSEs within the above mentioned 25% reservation to make it more inclusive and
- These amendments will come into force with immediate effect.

This Order may be called the Public Procurement Policy for Micro and Small Enterprises (MSEs) Amendment Order, 2018, which was notified by Ministry of MSME through Gazette Notification No.4455, S.O. 5670(E) dated 09.11.2018. Copy of Gazette Notification, letter dated 09.11.2018 and office memorandum dated 08.01.2019 mentioned above are enclosed for ready reference and for compliance of the guidelines issued by the Ministry of MSME.

Keeping in view of above, proforma for submission of monthly details of procurement is changed and enclosed herewith. It is requested to submit monthly procurement information



As per above amendments in Tender documents should also be done.



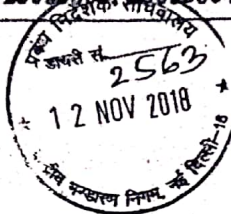

Subject: Amendment to Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 Implementaion-reg

Sir,

As you may be aware that Ministry of Micro, Small and Medium Enterprise (MSME), Government of India has notified Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 which mandates 20% of annual procurement by the Central Ministries/ Departments and CPSEs from MSEs including 4% from MSEs owned by SC/ST entrepreneurs. This Policy has become mandatory w.e.f. 1st April, 2015.

It has been felt that an enhancement of benchmark preference from 20% to 25% and 3% reservation for women would further help the MSEs immensely in the Government's 'Make in India' initiative. Accordingly, a proposal to make amendment in the Public Procurement Policy for MSEs Order, 2012 has been submitted to the Cabinet and Cabinet has approved the following:-

- (a) To increase in the percentage of procurement of goods and services by Government Departments/CPSEs from MSEs from the present at least 20% to at least 25% of their total procurement;
- (b) To provide for a minimum of 3% reservation for women owned MSEs within the above mentioned 25% reservation to make it more inclusive; and
- (c) These amendments will come into force with immediate effect.

It is therefore requested to kindly implement the above and also indicate the procurement made from MSEs owned by women for which link has been already provided in the MSME Sambandh Portal.

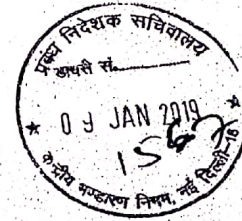

Sub: Implementation of Public Procurement Policy

The undersigned is directed to invite reference to D.O. of M/o MSME, regarding Implementation of Public Procurement Policy, vide which it has been informed that Hon'ble Prime Minister has recently increased the mandatory public procurement limit from 20% to 25% from MSEs including a sub-target of 5% procurement from the MSEs owned by SC/ST entrepreneurs.

2. In this regard, it is to be informed that M/o MSME, in association with the Federation of Indian Chambers of Commerce and Industry (FICCI) is conducting various business engagements in the coming months across the country. These include:

- i) Stakeholders' Consultation Meeting being proposed for 5th Feb 2019. It will also include felicitation and recognition of work done by select CPSEs to support SC/ST Entrepreneurs;
- ii) Buyer Seller Meets (BSMs) at select States, to address any demand supply gaps and enable a direct market access both for the SC/ST entrepreneurs and the PSUs;
- iii) Mega Culmination event to showcase the key achievement, to be held in March/April 2019.

3. In view of the above, a format has been prepared by M/o MSME (Annex I), to seek relevant inputs from the respective CPSEs. It is therefore, requested to kindly furnish the information, in the prescribed format to the M/o MSME, under intimation to DPE, at the earliest.



As you must be aware, Hon'ble PM has launched a far reaching Support and Outreach initiative for the benefit of Micro, Small and Medium Enterprises (MSME). One of the key announcements made in this regard is the amendment to the Public Procurement Policy (PPP). The changes effected therein are expected to improve the market accessibility and enhance competitiveness of the MSEs. They will also help in women empowerment.

2. The amendments so effected have been duly notified vide Government of India Gazette Notification S.O. 5670(E) dated 9th November, 2018. A copy is enclosed herewith for ready reference.

3. The amendments made in the PPP are as follows:-

- (a) Increase in percentage of procurement of goods and services by Government Departments/CPSEs from MSEs from the present at least 20% to at least 25% of their total procurement and
- (b) Provide a minimum 3% reservation for women owned MSEs within the above mentioned 25% reservation.

4. It may please be noted that the amended policy has come into force with immediate effect i.e. from 9th November, 2018 (date of the publication of the notification).

5. I shall be grateful if all the CPSEs under your control are advised to implement the above changes made to the Public Procurement Policy and to provide information on procurements made from MSEs owned by women. MSME SAMBANDH Portal has been updated accordingly for the benefit of the CPSEs.

6. Top Priority may kindly be accorded to this matter.

क्र.सं. 5670(अ).—केंद्रीय सरकार, सूक्ष्म, लघु और मध्यम उद्यम विकास अधिनियम, 2006 (2006 का 27) के धारा 11 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, सूक्ष्म और लघु उद्यम (एमएसई) के लिए सार्वजनिक प्राप्य नीति अक्ट, 2012 में निम्नलिखित संशोधन करता है:—

1. (i) यह आदेश सूक्ष्म और लघु उद्यमों (एमएसई) के लिए सार्वजनिक प्राप्य नीति संशोधन आदेश, 2018 कहा जाएगा।
(ii) यह सरकारी राजपत्र में अपने प्रकाशन की तिथि से प्रवृत्त होगा।
2. पूरे सूक्ष्म और लघु उद्यमों (एमएसई) के लिए सार्वजनिक प्राप्य नीति आदेश, 2012 (जिसे इसमें इसके पश्चात् उक्त आदेश कहा गया है) में जहां कहीं भी आंकड़े और शब्द "20 प्रतिशत" हैं उसे "25 प्रतिशत" के आंकड़े और शब्द 11 प्रतिस्थापित किया जाएगा।
3. उक्त आदेश के पैराग्राफ 4 के पश्चात् निम्नलिखित पैरा को जोड़ा जाएगा :-
"4 क. महिलाओं के स्वामित्व वाले सूक्ष्म और लघु उद्यम के लिए विशेष प्रावधान। सूक्ष्म और लघु उद्यमों से कुल वार्षिक खरीद में से 25 प्रतिशत के लक्ष्य के अंदर महिलाओं के स्वामित्व वाले सूक्ष्म और लघु उद्यम से खरीद के लिए 3 प्रतिशत का लक्ष्य निर्दिष्ट किया जाएगा।"

ORDER

New Delhi, the 9th November, 2018

S.O. 5670(E).—In exercise of powers conferred by section 11 of the Micro, Small and Medium Enterprises Development Act, 2006 (27 of 2006), the Central Government hereby makes the following amendments to the Public Procurement Policy for the Micro and Small Enterprises (MSEs) Order, 2012 namely :—

1. (i) This Order may be called the Public Procurement Policy for Micro and Small Enterprises (MSEs) Amendment Order, 2018.
(ii) This shall come into force on the date of its publication in the Official Gazette.
2. Throughout the Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012, (hereinafter referred to as the said Order), for the figures and word "20 per cent", wherever they occur, the figures and word "25 per cent" shall be substituted.
3. After paragraph 4 of the said Order, the following paragraph shall be inserted, namely:—
"4A. Special provision for Micro and Small Enterprise owned by women. Out of the total annual procurement from Micro and Small Enterprises, 3 per cent from within the 25 per cent target shall be earmarked for procurement from Micro and Small Enterprises owned by women.
