Sub: Accounting of TDS credit received under respective year-wise TDS 26 AS Available Ledgers w.e.f. FY 2022-23.

- 1. The TDS Control accounts are being maintained year-wise in Tally ERP for controlling and monitoring of the amounts of tax deducted by various CWC's customers/Payers and to ensure their availment by checking credit in Form 26AS of Income Tax (year wise).However , the ledger for transferring the TDS credit availed was not available year-wise in the Tally.
- 2. In order to improve the accounting and controlling of TDS credit, a Sub Group for Tax Deducted at Source-26AS Available A/c has been created, under which following Year wise ledgers shall be created for transferring of amounts of TDS Control A/c to respective year wise TDS Availment A/c at time of credit reflection in Form 26 AS.

- 3. Therefore, regions are required to pass the entries in the respective year wise TDS 26AS Available Ledgers w.e.f. FY 2022-23.
- 4. Balance under the ledger code 29102- TAX DEDUCTED AT SOURCE-26AS (AVAILABLE) A/C lying in RO books as on 31.03.2022 will be absorbed by CO before closing of accounts and <u>29102 shall have NIL balance in RO books as on 31.03.2022</u>, as already intimated vide Accounting Circular#58 dated 04.03.2022.
- 5. Accordingly, credit availability be verified with 26AS and be transferred as on 31.03.2022 from TDS Control ledgers (29110) to 26AS Available A/c (29102) and Schedule B7 (Other Schedule) Year-wise details of Credit in 26AS be furnished to Taxation Cell,CO by 11.04.2022. (with TDS credit reconciled upto 3rd Quarter of FY 2021-22) so that timely entries be passed at CO as on 31.03.2022.
