Note: In case of Inpatient treatment; charges payable to hospital for IPD Consultation per specialist, shall be limited to 02 consultations per day.

### Issue of authority letter

The employees are to be admitted by the hospital for indoor treatment as per the entitlement of room category mentioned above, limited to entitled room charges and for this purpose, proper authorization letter to be issued by the officials duly authorized by the Competent Authority of Regional Offices and Corporate Office.

**If the accommodation of entitled category is available and employee insists for higher category of room, the differential amount of the room charges would be borne by the employee which will be collected by hospital at the time of his/her discharge.**

The indoor treatment for the employees and their dependent may be taken for illness of specialized diseases, which cannot be treated at OPD. The authorization letter shall be issued for indoor treatment on the recommendation of the hospital and not for the investigation, diagnostic procedures etc.
