- 1. Copy of GST Registration along with quotation document shall be submitted.
- 2. The works shall be carried out as per CPWD specification & as per the instructions of the engineerin-charge of the work.
- 3. Time allowed for completion of work is 15 Days.
- 4. The rate quoted to be remain valid for 60 (Sixty) days w.e.f. date of opening of bid.
- 5. Quotationers are required to quote their rate in Rupees (in figure as well as in words) against each item in schedule.
- 6. In case the lowest quoted amount of two or more consultants is same, then such lowest consultant may be asked to submit sealed revised offer quoting rate of each item of the schedule of quantity and submission of the same within 3 days from date of intimation, but the revised quoted rate of each item of schedule of quantity for all items should not be higher than their respective original rate quoted already at the time of submission of quotation. The lowest quotationer shall be decided on the basis of revised offer.
- 7. If the revised quoted amount (worked out on the basis of quoted rate of individual items) of two or more consultant received in revised offer is again found to be equal, then the lowest quotation, among such consultant, shall be decided by draw of lots in the presence of Evaluation Committee and the lowest consultants those have quoted equal amount of their quotations.
- 8. In case of any such lowest consultant in his/her revised offer quotes rate of any item more than their respective original rate quoted already at the time of submission of quotation, then such revised offer shall be treated invalid. Such case of revised offer of the lowest consultant or case of refusal to submit revised offer by the lowest consultant shall be treated as withdrawal of his quotation before acceptance.
