TERMS AND CONDITIONS

1. ELIGIBILITY CRITERIA :

Quotationer who fulfills the following requirements shall only be eligible to quote the rates.

- i) EMD & tender processing fees : As per Sl.No.27 (Annexure A)
 - ii) Experience certificate : As per Sl.No. 27 (Annexure A)
2. Security Deposit will be deducted @10% of gross amount of bill of the contractor which will be refunded after successful completion of defect liability period of **six months**. In case any defects are found within defect liability period, the same shall be rectified by the Contractor immediately at his own cost. EMD deposited along with the quotation shall be adjusted against the security deposits to be deducted from the bills of the contractor.
 3. Necessary taxes i.e. Income Tax & other statutory taxes levied by Govt. time to time will be deducted from the bill as per prevalent rate as on date.
 4. **Quotationers/bidders shall quote their rates inclusive of GST, as applicable and GST will not be paid/reimbursed by CWC.**
 5. GST, Building or other construction workers cess or any other tax, levies, duties on materials and on complete works in respect of this contract shall be payable by the contractor and CWC will not entertain any claim what so ever in this respect. This should be included in the rates quoted by contractor.
 6. The contractor shall be required to pay labour cess @ 1% of cost of construction work in accordance with each bill payable on account of such construction to the concerned State of Govt. (Labour Deptt.) Cost of material shall be outside the purview of cess, when supplied under a separate schedule items. CWC shall not entertain any claim whatsoever in this respect.
 7. Contractor will have to arrange all labour, T&P etc. (at all levels) required for the execution/completion of the work as per site condition. Safety of working labour's lies on contractor only at all levels.
 8. Items & Quantities given in the schedule are tentative to give an idea of work involved which may vary as per actual execution at site.
 9. Work shall be executed strictly as per CPWD specification/Schedule. Work is to be completed **15 days** from the third day after the date of issue of work order.
 10. The Contractor will sign each paper of Quotations in token of acceptance of their offer.
 11. The offer rate shall be valid for 60 days from the date of opening of quotations.
 12. The time for execution of the work specified in the work order shall be deemed to be essence of the contract and the work must be completed within the specified period. If the contractor fails to complete the work within the specified period mentioned in the work order, the Competent Authority may at his discretion extend the date of completion and also consider levy of compensation as deemed fit based on the merit of the case.
 13. In the event of any documents found forged/fabricated/tampered/ altered or manipulated, then the EMD of the Contractor would be forfeited and he would be debarred for participating in CWC for 5 years.

14. If, the work is not started by the contractor within 1/8th of stipulated time.

Or

The contractor having been given a notice in writing to rectify, reconstruct or replace any defective work or fails to complete the work within the stipulated date or persistently neglects to carry out his obligations under the contract and does not remedy it or take effective steps within 7 days after the notice, the Engineering-in-Charge shall have power to rescind the contract and the EMD, security deposit already deducted under the contract shall be liable to be forfeited.

15. No advance payment shall be made at any time and payment shall be made only after execution of items/work.

16. Before quoting the rates, contractor may visit the site during office hours.

17. The Contractor shall not sublet/assign the contract work to any other contractor.

18. The contractor will have to abide by the labour laws and have to extend the statutory due benefit to the person deployed and the CWC will not be held responsible for any compensation in case of any mis-happening during contract period.

19. Contractors submitting bid on behalf of a firm/Company must submit partnership deed or Certificate of Incorporation of the Company and Power of Attorney in the name of person signing the tender/quotation.

20. It is a works contract and there is no EMD exemption on account of MSME.

21. Contractor will upload the bank details (cancelled cheque), copy of GST certificate and copy of PAN card & affidavit as per Annexure II or Annexure III as the case may be.

22. Contractor shall produce cement purchase voucher, paint purchase voucher etc. for releasing the payment of relevant items.

23. CWC reserves the right to accept or reject any or all the quotations without assigning any reason thereof.

24. No interest shall be allowed on the Earnest Money/ Security Deposit.

25. In the case of Extra Item(s) / Substituted item(s) being the schedule items (Delhi Schedule of Rates 2021 items), these shall be paid as per the schedule rate plus / minus percentage (above / below) quoted rate. Payment of Extra items /Substituted item(s) in case of non-schedule items (Non- DSR items) shall be made as per the prevailing market rate.

26. In case of contract items which exceed the limits laid down (25 % for the foundation work and 25 % for the super structure work) the contractor shall be paid rates at agreement rate / market rate whichever is lower. The prescribed time limits for finalizing extra item(s), substituted item(s) and deviated quantities of contract items is within 30 days after submission of proposal by the contractor without observation of the Engineer In charge.

MINIMUM ELIGIBILITY CRITERIA**i. EMD & Tender Processing Fees :**

- a) The EMD to be paid in favour of **Regional Manager, Central Warehousing Corporation, Regional Office, Kochi only through e-payment gateway of e-procurement** and receipt of the same should be scanned and uploaded on the E-tendering website www.cwceprocure.com along with E-quotation documents.
- b) Tender/quotation processing fee (Non-refundable) would be paid mandatorily to M/s ITI Ltd. through e-payment on the portal www.cwceprocure.com.

ii. Experience Certificate:

Quotationer should have completed successfully at least one similar nature of work " (i.e. **Any civil engineering works**)" of value not less than **Rs.48,000/-** (35% of the advertised Estimated Cost) during the preceding four financial years (i.e. **2018-19 , 2019-2020 , 2020-2021 and 2021-2022**) & current year (**2022-2023**) upto the date of quotation submission. **Certificate should include the name of work, agreement no./work order no., actual date of completion & gross amount of work done upto the completion.**

It should be noted that credentials for the works executed for Private Individuals shall not be considered.

iii. No Technical / Financial credentials are required under the eligibility criteria of clause 1(ii) of terms and conditions for the NIQ of value up to Rs. 25 lakhs- In following case

- a) If quotationer is an enlisted contractor of CPWD / Railways / MES / State PWDs / Other Govt. Organisations / Public Sector Undertakings and their Subsidiaries and his enlistment is valid for at least one year from the date of NIQ opening.

OR

- b) If the quotationer have worked / working with aforesaid Govt. Departments / Agencies during the last four financial years (i.e., **2018-19 , 2019-2020 , 2020-2021 and 2021-2022**) & current year (**2022-2023**)) up to the date of NIQ submission.

OR

- c) The quotationer or one of his partners (partnership firm) is an unemployed Graduate Engineer /Architect passed from Recognized university /Institute in India.
