**PROCEDURE UNDER E-AUCTIONING  
INSTRUCTIONS TO APPLICANTS**

**1. DEFINITIONS**

M/s MSTC Limited: Service Provider for e-auctioning portal on behalf of Central Warehousing Corporation (“CWC”) introduced for the process of e-auctioning/E-tendering which can be accessed on <https://www.mstcecommerce.com>.

Words in capital and not defined in this document shall have the same meaning as in the Auction document.

**2. Registration of user and ACCESSING OF BID DOCUMENTS:**

- i. It is mandatory for all the Applicants to have digital signature certificate (in the name of person who will sign the Application Form) from any of the licensed certifying agency (“CA”) \*Applicants can see the list of licensed CAs from the link [www.cca.gov.in](http://www.cca.gov.in) to participate in e-auctioning Process.
- ii. To participate in the auction, it is mandatory for the bidders to get registered with e-auctioning portal <https://mstcecommerce.com> by making registration charges. The intended bidder may contact Mr. Marut Saha, Manager:0265-2960354/2960379/2960385/-extn.: -204. e-mail: [marutsaha@mstcindia.co.in](mailto:marutsaha@mstcindia.co.in)/[mstcvda@mstcindia.co.in](mailto:mstcvda@mstcindia.co.in), for registration process.
- iii. Documents can be viewed/downloaded, free of cost, till last date and time of purchasing documents from <https://mstcecommerce.com> & CWC website- [www.cewacore.nic.in](http://www.cewacore.nic.in). The amendments/clarifications to the Auction, if any, will be posted on both websites.
- iv. If the Applicant has already registered with the Service Provider and validity of registration has not expired, then such Applicant does not require fresh registration.

**3. SUBMISSION OF ACCEPTANCE FORM AND CMD/PBD:**

- a. Detailed Auction Documents may be downloaded from e-Auction URL and the Scanned Copy of Bidder Acceptance Form (Annexure-II) & CMD/PBD may be submitted online before last date and time for submission. A Vendor manual containing the detailed guidelines for e-auctioning system is also available on Auction portal.
- b. It may be noted that the scanned copies can be prepared in file format i.e. PDF and/or JPEG only. The Applicants can upload a single file of size of 5 MB only but can upload multiple files.

**4. ADDENDUM TO THE AUCTION:**

Any Addendum to the Auction shall be uploaded only on the e-auction portal & CWC website. Online bidding process : Once the bidder submitted acceptance and EMD form upon registration , the bidder to follows vendor manual for bidding instruction which is available at e-auction portal.

**5. NOTE:-**

- i. Unless Caution Money Deposit /Pre-Bid Deposit (CMD/PBD) paid in advance to MSTC through pay-pre-bid EMD link on bidders login, No one can enter the Auction process at e-Auction Portal. The bidder shall comply instruction/information as stated at S/No. 3 and 4(Schedule of Programme) of page-2 .
- ii. Complete offer document/auction catalogue is available on <https://mstcecommerce.com> and CWC website [www.cewacor.nic.in](http://www.cewacor.nic.in) .Corrigendum, if any, shall only be available on above websites.

DISCLAIMER: Bidder must read all the instructions in the Auction document and submit the same accordingly

ANNEXURE-IGENERAL CONDITIONS OF SALE/AUCTION

The auctioneer shall incorporate below mentioned conditions in auction catalogue:

**1.1 DEFINITIONS**

**SELLER** – Seller referred in these conditions of sale, is the Custodian, Central Warehousing Corporation, Regional Office, Ahmedabad (hereinafter referred to as CWC)

**AUCTIONEER** – M/s MSTC Limited, an agency appointed as a Service Provider/ Auctioneer to facilitate auction on e-auction/ Internet on behalf of the Custodian (CWC) on their website <https://mstcecommerce.com>. They are expected to facilitate organizing and conducting an auction and are considered as third party not particularly interested in the item being sold for and on behalf of the Central Warehousing Corporation

**BIDDER** – Any person representing as an individual OR as proprietor OR as a partner OR as an authorised representative of any company and who is Registering himself on the website <https://mstcecommerce.com> and paying the stipulated amount of Earnest Money/Caution Money to decide/ set their bidding Limits is considered as a Registered Bidder. One individual can represent as a bidder on his own behalf and on behalf of other persons/ companies provided he registers himself in those capacities separately i.e. for each representation he should pay separate stipulated caution money and set the Bidding Limits. But he can't register separately for himself & company at the same time.

**1.2. PARTICIPATION**

- (i) Only REGISTERED Bidders shall be allowed to participate in the on-line auctions. To become REGISTERED Bidder one needs to register with the auctioneer website <https://mstcecommerce.com> either on-line at office of auctioneer.
- (ii) All the Bidders need to register with GST and copy of certificate referring GST Registration Number and any other document as per requirement of Auctioneer needs to be submitted with AUCTIONEER for updating Bidder's Registration details. AUCTIONEER/Seller will not be liable to issue any Sale Order/Delivery Order/Invoice etc. wherever GST Registration Number is not submitted.
- (iii) Registered Bidders will be required to E-mail/Fax/Courier/Upload a duly signed copy of the Form "**Acceptance to Participation**" Form given in Annexure –II to MSTC/CWC Website, thereby giving their consent to terms and conditions of the Online Auction Sale. The Auctioneer will activate Identity and Passwords of the Registered Bidders in the Online Auction method of Bidding ONLY after receipt of the signed "Acceptance to Participation Form" and On Payment of prescribed CMD/PBD. Bidder shall **enter a valid e-mail ID** in the Registration/Acceptance Form. All e-mail communications will be forwarded to the e-mail ID entered in the Registration Form.

- (iii) **Time Extension:** If any market-leading bid (bid higher than the highest at the point in time) is received within the last 8 minutes (“Time Extension” as mentioned in the Bidding Room will be in force & 8 Minutes is an example) of closing time, the time will be extended automatically by 8 minutes.
- (iv) **Auto Bid:**
- a. Auto Bid facility is provided for bidders intending to place a maximum value for a lot/lots.
  - b. Auto bid is not a confirmed bid. It is only the maximum ceiling amount set by the bidder to enable the auction engine to place bids on his behalf, whenever he is outbidder, upto the ceiling set by him.
  - c. Once auto bid is set, the auction engine will consider the ceiling amount for the next possible Bid only, depending on the highest bid prevailing at that point of time and the incremental amount prescribed for that particular lot.
- (v)
- a. Bidder shall bid “LOT-WISE” only. Acceptance/rejection of highest bid will also be lot-wise. During the process, every lot will be treated as separate line.
  - b. The rates will be exclusive of any Tax i.e. basic rates.
  - c. Lot-wise start price will be Rs.1000/- with incremental value as per Appendix - I .
  - d. The process will be as Standard auction. The bidder shall be able to see their own bid and highest bid only, without any information/identity of other bidders.
1. The highest bid for each lot shall be subject to the confirmation by seller (CWC) hereinafter mentioned as STC.
  2. The goods will be sold on lot basis and the delivery will be given as lot only. Goods may be sold in one or more lots as found suitable and convenient and / or advantageous in the interest of the CWC.
  3. Any lot or part thereof may be withdrawn from sale at any time before it is actually sold / delivered without assigning any reason for such withdrawal.
  4. All bids received will be the net purchase amount against subject lot and all taxes or other levies charged, VAT/GST or local taxes/laws as applicable on the date of delivery except Customs Duty shall be payable by the bidder. These taxes are required to be paid before taking delivery by the bidder/tenderer.
  5. **CONDITIONS OF PAYMENT:**
    - i] The bidder who wants to participate in online Auction shall pay Lot-wise Caution Money Deposit /Pre-Bid Deposit (CMD/PBD) as fixed by the Regional Manager, CWC, RO, Ahmedabad and as shown at APPENDIX-I to the MSTC as per MSTC process. No bidder shall be allowed by MSTC without registration and payment of CMD/PBD.
    - ii] All the bids above/equal/ below 5% of Reserve Price (RP) shall be accepted by MSTC and “SALE INTIMATION LETTER” letter will be issued to Successful bidder, but considering involvement of Customs/Other Statutory agencies, all bids will be on “Subject To Approval (STA)” basis. The bidder whose bid has been accepted on “ STA Basis” , have to pay 20% of purchase price as EMD with CWC within 3 (Three) working days from the date of intimation/Confirmation from MSTC, failing which their CMD/PBD shall be forfeited. *However,*

for delay due to genuine reasons, on the written request of successful bidder, extension up to 7(seven) days can be considered by the Regional Manager, CWC, RO, Ahmedabad, for payment of EMD with the condition of levy of penalty @ 1% of bid value. The decision of the RM will be final and binding on the bidders to decide genuineness of reasons for delay and quantum of days to be allowed. The amount of CMD/PBD paid by the bidder can be adjusted against the EMD payable.

- iii] Once the bid is accepted by CWC, “Bill of Entry for uncleared goods” shall be filed with Customs by Custodian (CWC) for assessment of Customs Duty and clearance.
- iv] The confirmation for delivery of cargo shall be intimated after getting the approved/ Processed Bill of Entry in the name of the successful bidders from the Customs Department. The bidders shall have option to collect the approved/Processed Bill of Entry from CWC, arrange payment of Customs Duty to Customs, get Out of Charge Order from Disposal Section at Custom House and submit the same to CWC alongwith payment of Balance Bid amount and VAT/GST as applicable and take delivery of the auctioned goods / cargo within Seven (7) days from the date following the date of “Out of Charge” Bill of Entry. However, for delay due to genuine reasons, further extension on the written request of the successful bidder, for depositing balance bid amount and taking delivery of goods, can be considered by the Regional Manager, CWC, RO, Ahmedabad, with the condition of levy of penalty @ 0,5% of bid value for first seven days and 1% of bid value for 2<sup>nd</sup> segment of seven days. The decision of the RM will be final and binding on the bidders to decide genuineness of reasons for delay and quantum of days to be allowed. Further, purchasers shall bear the interest, penalty if any, levied on duty by Customs.

- vi] The buyers have to make payment by RTGS/NEFT from their own account only. No third party payment shall be accepted.
- Vii] If the bidders fail to take delivery of the cargo within the stipulated time, as stated above, the Corporation, i.e. CWC may at its discretion extend the delivery period on request of the successful bidder for a maximum period of fifteen (15) days after the expiry of free period of Seven (7) as mentioned at Sl. No. iv, on payment of Ground Rent by the purchasers as per tariff fixed in this regard.
- viii] If the purchaser fails to take the delivery of the goods within the maximum period permitted by CWC on payment of rental warehousing charges as detailed above, the CMD/PBD/EMD or any

amount lying with the CWC against said lot(s) will be automatically forfeited and the Cargo will be re-listed for the sale without any further notice.

- ix] The Delivery of the goods will be given on Working days during 10:00 hrs to 17:00 hrs only or as decided by the Manager (CFS/ICD/Warehouse) of respective CFS/ICDs/Warehouses.
6. The purchaser of each lot shall give his name, address, fax number, e-mail, phone / mobile number to the auctioneers. If the purchaser fails to pay the earnest money within admissible period, after the lot is knocked down to him, the bid shall forthwith be cancelled, CMD/PBD will be forfeited and the lot will be re-auctioned. No claim of bidder will be entertained in this regard.
  7. No sale shall be invalidated by reason of any defect or faults in any of the lots being in-correctly described and no compensation shall be paid in respect of any such faults or errors of description.
  8. The goods are sold "AS & WHERE THEY LIE" condition. The lot or lots shall be removed in full from the site with all faults and flaws in description or otherwise and no selection or sorting of the material will be allowed. quality, quantity, size, measurement, number and weight stated are approximate. Goods are sold on the assumption that the bidders have inspected the lot prior to the bidding and know what they are bidding for. No complaint shall be entertained after the lot is once knocked down / highest bid accepted.
  9. The goods shall lie at the sole risk and responsibility of the Purchaser in all respects from the time of sale and must be taken away by the Purchaser at his own expenses within stipulated time.
  10. If the goods are not removed within the specified period, the EMD and the other payment made by the Purchaser will be forfeited. Similarly, in case, CWC Administration could not deliver the goods within the specified time due to unanticipated administrative reasons, suitable extension of period shall be granted to the purchaser and he will not be liable to pay ground rent or any other charges, till the expiry of such extended period of date of intimation whichever is earlier.
  11. When CWC's unserviceable items/scrap goods are sold on basis of lots and the purchaser fails to obtain the delivery of the whole or portion of the goods sold, he shall not be entitled to make any claim other than for the proportionate refund of the value of the undelivered quantity. He shall not be entitled to claim any damage, loss or profit, interest on compensation or any other account, access quantity, if any, will be paid for in advance before the material is removed.
  12. All bidders/ purchasers shall be deemed to have read and acquainted themselves with these conditions of sale and agree to give their bids subject to these conditions. The bidder shall be deemed to have self satisfied regarding eligibility for a particular lots. No claim from any bidders regarding their eligibility shall be entertained at any later stage and any payment made by the bidder against such lots, shall be liable for forfeiture. The decision of the Regional Manager, CWC,RO, Ahmedabad in this regard, will be final and binding on bidder.
  13. The delivery of the goods either in part or in full would be subject to being withheld, if required, by CWC at any stage before actual delivery, without assigning any reason and delivery will be taken by the bidder/ after permission by the CWC.
  14. CWC shall not be responsible for any loss or liabilities of the bidders if the purchased lots could not be delivered due to circumstances beyond control.

15. If the goods other than mentioned are found at the time of delivery, the sale may be cancelled by the CWC administration. In such case the refund of EMD or any other payments made by the purchaser shall be given by the CWC without any interest unless it is forfeited as above.

**SPECIAL CONDITIONS:**

16. The decision in respect of bids accepted by CWC on “ Confirm/STA”, the decision will be announced within 180 (One hundred Eighty ) days of the auction commencement date or further extended time thereafter by CWC which will be informed to the bidder. If the bidder indicates his unwillingness to wait further, beyond 180 days, the sale will be cancelled and CMD/EMD, if any, against a particular lot, will be refunded to the bidder under intimation to Customs. The Confirmation of Sale will be issued after getting clearance from Customs.
17. Any information regarding acceptance under STC, other information such as notices, extension of time etc. will be communicated to the respective bidders through E-Mail. Bidder also should be in touch through mail/digital mode with the auctioneer/CWC to have exact information.
18. For delivery of the lots particularly for those sold on weight basis, the purchasers are requested not to wait for the last date of free period to effect delivery as no extension of time will be allowed for any reason whatsoever for extra payment of price or additional quantities as ascertained at all the time of weighment. The purchaser will be required to make his own arrangement for providing weighment equipments, labour etc if facility is not available at the unit or if facility available at unit the bidder shall pay charges accordingly.
19. Purchasers are required to complete all the formalities connected with ADC/ PHO/ Custom/PPQ/Any Statutory Authority at their own (charges/fee, if any, in this regard, to be borne by bidder), before goods are delivered to them.
20. For all the goods sold on subject to mutilation and fumigation and allied Custom/ Assistant Drug Controller / Port Health Officer / Pollution Control Board formalities, free period of 30 (Thirty) Calendar days only will be allowed for completing all formalities from the date of confirmation of offer. If the concerned authority does not certify/convey the approval within the time specified, the purchaser will have the option to come forward and withdraw the offer within 15 days i.e. before the expiry of 45 (Forty Five) calendar days not apply for cancellation of sale, the warehouse rental charges as notified in the CWC Tariff will be recovered from the 31<sup>st</sup> day following the date of confirmation of offer. The earnest money deposit / Purchaser’s Price will be forfeited and the sale will be cancelled if the purchaser does not withdraw the offer between 31<sup>st</sup> day and the 45 the days following the date of confirmation of the sale. No gas cutting equipment or any equipment, which are likely to cause damage, will be allowed in the CWC premises. The decision of the CWC’s Officer or his authorized representative shall be final in this regard. However, if allowed, the Goods shall be mutilated only under Custom’s Supervision to avoid misuse of Trade Mark, Name etc. and at the risk & cost of bidder. The bidder shall be liable to make good the losses to the CWC premises and any other harms/injury to the personnel(s) in this regard.
- 21.(i) GST rates will be applicable as per norms. Actual GST rates as applicable on the date of lifting shall be applicable. Bidders are required to satisfy themselves about GST rate through their own sources/ means before bidding in this e-auction and any discrepancy should be intimated to (AUCTIONEER)/Seller at least one working day prior to the e-auction. No intimation in this



- regard will be entertained after the e-auction goes on live floor. No complaint, grievance or dispute from any bidder regarding any variation will be entertained by the Seller/Auctioneer.
- (ii) Any variation in GST or other relevant tax and any fresh statutory levies will be borne by the bidders/buyers. Auction sale shall be treated as local sale only. "C Form" against outstation sale will not be accepted by CWC. Full GST will be collected at the prescribed rates. Bidders should make their own arrangements under applicable GST laws to take the goods to their state. Non-payment of sale proceeds on the ground of any discrepancy of GST rate will be treated as default and action as deemed fit including but not limited to forfeiture of EMD/any other amount, will be taken against the bidder.
22. While bidding for the lots, the bidders are advised to take note in their own interest that the bids for such restricted items for example plastic scrap, metal scrap etc. should be quoted if they are so eligible. They should submit license/certificate as required under Customs Act/Policy to the Customs/CWC before taking out of charge from Customs. Failure to comply, shall lead to cancellation of bid/sale and forfeiture of CMD/PBD amount lying with CWC. Further, to ensure that consignments of bulk drugs are sold only to actual users i.e. manufactures holding valid manufacturing license under Form 25 and 28 with valid permission for the usages of the said bulk drugs in its formulation, the bidder should attach the following documents to their offer forms.
- i] Counterfoil of the application form alongwith a Xerox copy, submitted by the actual user holding license to the bank for obtaining Demand Draft / Pay Order should be attached to the offer form alongwith the DD / PO.
- ii] Likewise, the purchaser while bidding in auction should produce the documents (i) in original or copy duly certified by the Asstt. Drug Controller. Initial verification of requisite documents will be done by the officer of Sales branch attending tender. Only the authorized representative of the manufacturing firm is permitted to bid in the auction. He should produce authority letter from his firm for inspection before acceptance of the offer.
23. In case of Drugs etc. such as Citric Acid, Potassium Permanganate, Phenyl etc. which may be found fit for medical or non-medical use as advised by the Asst. Drug Controller from time to time, offers will be entertained from the actual users only and while giving the offers at the time of Tender / Auction, they should fulfill condition No.8 otherwise their CMD/PBD/EMD stand forfeited. However, in case where Asst. Drug Controller has already certified the drug for non-medical use only, the actual user condition is not applicable. The delivery of such lots, which are certified for non-medial use, will be given after making as "NON-MEDICAL USE" on the packing in presence of Asst. Drug Controller. In such cases, it is the responsibility of the bidder to bring ADC.
24. In case of non approval of the lots by the ADC / PHO/PPQ, the sale of lots will be cancelled and EMD will be refunded to the successful purchaser. The approval of the Authority concerned shall have to be obtained by bidder within a maximum period of 30 days failing which EMD will be forfeited.
25. All the goods sold at the Auction sale shall lie at the sole risk of the purchaser until the goods are removed.
26. The Regional Manager, CWC, Ahmedabad reserves the right to withdraw any lot or part thereof including those sold on subject to confirmation even though only confirmation of ADC / PHO/PPQ or Fumigation will be pending at any time without assigning any reasons.

27. Sale of uncleared & unclaimed goods shall be subject to other conditions as may be specified from time to time as accordance with prevalent rules, regulations applicable to the CWC and Customs.
28. Lots should be inspected by the intending purchaser before making an offer and lots will be sold on “AS IS WHERE IS ” and “NO COMPLAINT ” basis. Neither the Auctioneer nor CWC is responsible for its quantity, quality, size, and measurement etc. of the goods. Goods are sold on the assumption that the bidder has inspected the lots prior to bidding and know what they are buying. Once an offer is accepted purchaser will have to take delivery of the goods not withstanding all the faults and flaws, if any, in the condition or description etc. of the goods irrespective of whether it was actually inspected or not. No selection or sorting or whatsoever of the goods will be allowed. Quantity, quality, size, measurement etc. are approximate. No sale shall be invalidated by reasons of any defects or faults in any of the lots or on account of the lots being incorrectly described and no compensation shall be paid in respect of any such faults or errors in the description. No inspection of lot, which are sold and subsequently confirmed, shall be permitted under any circumstances unless full purchase price is paid. No compensation shall be entertained after the lot is knocked down. No dispute in respect of size, measurement, number, weight will be entertained.
29. Resale will not be recognized & delivery orders will be made in the same name of actual bidders only. The original purchaser, whose offer has been accepted, wish to take delivery of the goods through a representative, he must authorize by a letter of authority which shall be presented to the Regional Manager, CWC. Delivery by proxy will be at the purchaser’s own responsibility and risk and no claim lie against CWC on any account whatsoever if the delivery is taken by the wrong person. No claim or damage or losses of any kind will be entertained on any account whatsoever.
