Interested parties may be submitted their rate per sample excluding GST and any other applicable taxes from time to time.

The parties should forward the Quotation preferably with their letter head mentioning the name, status/designation of the signatory, full address with Telephone no. /Mobile No. The Terms and conditions are enclosed with the Quotation. Quotation should be submitted in the **sealed Envelope subscribed "Rates for Chemical testing of Food grains Samples, accompanied by EMD of Rs. 5601/- through e-payment/NEFT/RTGS/ Demand Draft** and receipt of the same should be attached attested copy with Quotation documents of **Demand Draft in favor of Regional Manager, Central Warehousing Corporation payable at Lucknow**. Successful Bidder will have to **deposit 3% of contract value towards SD**. The EMD shall be returned to all unsuccessful quotationers, as soon as practicable after decision of Quotations and to a successful quotationer, after he has furnished the security deposit; if the successful Quotationer does not desire the same to be adjusted towards security deposit. EMD/SD will not carry any interest. NSIC registered firms are exempted from depositing EMD/SD and Quotation cost as per MSE notification of Govt. of India dated 23.03.2012 or any other notification issue thereafter.

The Quotation shall be sent by Registered post or delivered by hand in time which shall be opened at **Central Warehousing Corporation, Regional Office, Near Roadways Workshop, Vibhuti Khand, Gomti Nagar, Lucknow** in the presence of parties who wish to be present at their own cost. TERMS & CONDITIONS

1. Only parties having valid FSSAI/NABL registration certificate need to apply.
2. It is mandatory to submit FSSAI registration certificate, NABL accreditation certificate along with quotation.
3. Sample Analysis report are to be delivered in respect of concern central warehouse situated in Lucknow Region within 10 days of received of sample along with the bills in triplicate for processing/releasing of payment.
4. Quotation not accompanied with EMD shall be summarily rejected. The successful quotationer shall be required to furnish security deposit within a week of the receipt of Purchase order by Demand Draft failing which it shall be lawful for the Corporation to forfeit the earnest money and purchase the goods at the risk and cost of the successful quotationer. The EMD of successful bidder will be adjusted against SD, if the quotationer fails to furnish the security in the above manner. In case the contractor/supplier having been called upon by the Corporation to furnish security fails to do so within the specified period, the Corporation will be within its rights to recover from the contractor the amounts of such security deposit by deducting the amount from the pending bills of the contractor under this contract or any other contract with Corporation. The EMD of unsuccessful quotationer will be refunded back in full (without any interest) within 30 days of opening of Quotations / Quotations.
