The Proposal from Interested parties for setting of Infrastructure for industrial storage,/cold storage facility/Processing unit setup/commercial space/e-commerce storage/warehousing courier services/Transit warehousing facility/Food Processing unit/ and other services like grading, sorting facility/ packaging unit/other agro processing units like Rice Mills, Flour Mills, Daal Mills etc. in the godown/ warehouse compartment (s) by retrofitting at any or all the given locations of CWC on Built Operate Transfer (BOT) basis/Dedicated space on monthly rental @ CWC Published tariff basis in state of Uttar Pradesh.

The storage covered space will be provided by CWC at CWC Published tariff Applicable for storage.

This EOI Document is being published by the Central Warehousing Corporation (CWC), Regional Office Lucknow. The purpose of this EOI document is to provide interested parties to understand the scope of the Project and invite proposal from interested and eligible bidders/parties. Central Warehousing Corporation (CWC) is established under the Warehousing Corporations Act, 1962 and is functioning under the Ministry of Consumer Affairs, Food & Public Distribution, Govt. of India. CWC has been set up for providing warehousing services for storage of agriculture produce and other notified commodities. CWC is also operating Bonded Warehouses, General Warehouses as well as Inland Container Depots (ICDs) and Container Freight Stations (CFSs) all over the country. CWC, being a premier warehousing agency in India providing warehousing and logistics support services to diverse group of users of such services, has also diversified its activities into construction, operation and management of CFS and ICD at different places in India.

1. Eligibility Criteria for Technical Bid

1. TECHNICAL CRITERIA:

Bidder must meet the following criteria jointly or independently:

i. The bidder shall be a Controlled Atmosphere (CA), Cold Storage Project Developer/food processor (having valid FSSAI License)/supplier/ contractor/Equipment manufacturer of CA, Cold Storage having experience of setting up of similar plants which includes Cold storage, along with components mentioned in clause of scope of work, Pre-Engineered Buildings (PEB), Civil & Electrical work and utilities for cold storage. The bidder should have completed at least two similar works in India or abroad of value not less than Rs. 1 Crores.

OR

ii. The bidder shall have experience in successful Operation & Maintenance or running of facilities which includes CA/MA Cold storage, or any food processing units or other similar kind of work for the period of at least 3 years. The bidder should submit details of at least one similar project in India or Abroad for which it has taken operation and maintenance or has an experience of running it for 3 years.

Bidder shall submit, in support to the above, the list of project(s) commissioned along with their work order and completion, commissioning, experience certificates from owner.

Note: The Bidder may also be a consortium or JV whose collective / individual experience should meet experience as mentioned in clause 1.i &1.ii.

2. FINANCIAL CRITERIA

- a) The average annual turnover of the bidder (Or aggregate of the members of the consortium) in the preceding three (3) financial years i.e.; 2018-19, 2019-20 2020-21, provisional shall not be less than INR 01 Crores (Indian Rupees one crores only) or in equivalent foreign currency. Statutory auditor certificate shall be furnished in this regard.
- b) The Net Worth for the last year of bidder should be in positive on the last day of the preceding financial year. In case where audited results for the last preceding financial year are not available, certification of financial statements from a practicing-chartered accountant shall also be considered acceptable, provided the bidder provides the detailed Financial Statements certified by the management of the company.

Notwithstanding anything stated above, the CWC reserves the right to assess the capabilities and capacity of the Bidder / collaborators / associates / subsidiaries / group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of CWC

CWC reserves the right to reject any or all bids or cancel/withdraw the Notice Inviting EOI without assigning any reason whatsoever and in such case no

bidder/intending bidder shall have any claim arising out of such action.

2. <u>Documents required to be submitted with Technical Bid:</u>

- 1. Application form duly filled, stamped and signed by authorized signatory of the company/ firm as per format (enclosed with Annexure-I) of this bid documents to be submitted with Covering letter at Annexure-I.
- 2. Self-attested& stamped copy of last three years audited Balance Sheet and Profit & Loss Account of the company / firm including copy of ITR.
- 3. Self-attested& stamped copy of GST registration certificate.
- 4. Self-attested& stamped copy of FSSAI license, if applicable.
- 5. Self-attested& stamped copy of PAN of the company/firm.
- 6. Self-attested& stamped copy of valid Registration Certificate of the company / Partnership deed.
- 7. Self-attested& stamped copies of some of the storage orders/Invoices of horticultural produce especially perishable commodities like apple executed by the company / firm in each of the last three years ending on 31st March, 2020.
- 8. Self-attested & stamped copy of valid address proof of the firm/company.
- 9. Self-attested copy of Aadhar card of authorized signatory.
- 10. Copy of the Board Resolution (in case of company) or Authorization Letter (in case of partnership firm) in favour of the Authorized Signatory.
- 11. Turnover and net worth certificate for the last three financial years issued by Chartered Accountant.
- 12. Self-attested& stamped copy of this bid document as a token of acceptance of terms & conditions of this bid documents.
- 13. List of Directors / Partners of the company/firm as per attached format at "IV".
- 14. Self-Declaration on letter head of the company / firm for not been blacklisted by any State/Central Govt. body/ Public Sector Undertaking at any point of time in India.
- 15. Self-Declaration on letter head of the company / firm for not been involved in any major litigation that may have an impact of affecting or compromising participation of the party in the e-auctions.
- 16. Self-Declaration on letter head of the company / firm for not been prosecuted for violation of rules / law under Essential Commodities Act or any such others law or orders there under in any court of law.
- 17. Self-declaration on letter head of the company / firm for not being under liquidation, court receivership and/or similar proceeding.
- 18. Self-declaration on letter head of the company / firm for not being under a declaration of ineligibility for corrupt and fraudulent practices.
- 19. Self-Declaration on Company's letter head that the CA storage is efficient for Storage of perishable commodity such as apple.
- 20. Details of plant and machinery
- 21. Copy of cancelled cheque of the company/firm.

3. Instructions to Bidders

a. CWC invites reputed firms to submit their proposals for the Project in accordance with conditions and manner prescribed in this Expression of Interest (EOI) document.

No Bidder shall submit more than one EOI however, may include more than one location in the single EOI.
