Terms and conditions of the AMC

Important: Tenders shall be submitted in a sealed cover duly super scribing **"Tender for AMC of Electronic Lorry Weighbridges and last date for submission is 16.08.2022"**.

1. **Scope :** Service and Maintenance of 10 No. Electronic Lorry Weigh Bridges at Central Warehouses viz., Belgaum/Dharwad / Gadag-I / Gadag-II /Gulbarga-I/Gulbarga-II (2 Nos.)/Hubli/Mangalore/Tumkur. The bidder shall maintain Weigh Bridge in trouble free condition without any variation in Weighment and avoid any penalty from the Department of Legal Metrology. The ELWB shall be ready for inspection by the authorities at any time. The bidder shall arrange quarterly servicing and maintenance once in three months in a year. The bidder shall attend to all emergency calls for rectification of defects reported by the respective Warehouse Manager, within a reasonable time to avoid Weighment on outside ELWB, in addition to quarterly service. The bidder shall be capable of replacing any spares damaged or not functioning in the ELWB. The bidder shall arrange inspection of ELWB which are due for annual stamping. Painting of platform, border frame annually before stamping.
2. **Period of Contract :** ONE (1) year with a provision to extend for 3 months on satisfactory performance during contract period.
3. **Quarterly servicing :** Servicing & maintenance work has to be undertaken at quarterly (once on three months) intervals for ELWB. Payment will not be arranged for the quarter for which they have not attended and period not covered in the service maintenance work.
4. **Break down calls :** The contractor shall attend to all breakdown calls intimated through email / phone calls, as and when required at no extra cost, within 48 hrs, reported by the respective Warehouse Manager / Incharge. No extra payment will be paid on account of attending breakdown / emergency repair calls.
5. The service contract period is liable to be extended on the same rates, terms and conditions for further period of three months or part thereof from the date of expiry of the initial contract period, at the discretion of the corporation.
6. The contractor can be terminated at any time during the contract period without assigning any reason thereof, after giving a prior notice period of seven days and payment of AMC as quarterly basis. (Our Corporate Office is in process of appointing a AMC service provider on national / zonal level for integration of all ELWBs in Bangalore Region. On finalization of a new contractor, then the current contract of "AMC of ELWB" of Bangalore Region will be cancelled. CWC, RO, Bangalore is not bound for agreed AMC for the period, it is awarded, in any situation).
7. **Penalty :** If the contractor fails to attend the breakdown call within 48 hours, a penalty will be levied @ Rs.1000/- per day after 48 hours. If the contractor, fails to attend the servicing of any ELWB during any quarter, the payment for the same quarter for the ELWB for which not attended will not be paid.

8. **AMC Inclusion** : All minor spares and IC of Digital Indicator included. Expenditure in deputing service engineer to the site for service and maintenance and for preparation of ELWB for stamping included. Expenditure on Annual painting of platform and external metal parts included.
9. **AMC Exclusion** : Spares which are not covered under AMC are Junction box, Load cell, Digital Indicator, Jumbo display unit , AD card, Processor card and display unit of Digital indicator, Worn out Bolt and Nut. Unskilled labour, UPS and batteries, Computer and Printer. Any parts which are damaged by fire, flood, lightning and high power flow are not covered under AMC.
10. **Stamping**: Stamping fees on actual basis will be paid by CWC through the respective Warehouse Manager or after submission of bill. However the service provider shall arrange inspection by the Department of Legal Metrology and stamping of ELWB on or before due date annually. Incidental charges for arranging stamping payable to Service Provider.
11. **AMC & SPARE PARTS RATE**: The bidder shall quote AMC rate in the price bid form showing taxes separately.
12. **Payment**: Payment of AMC charges will be paid on quarterly basis at the lowest rate quoted and approved by the Regional Manager, CWC, Regional Office, Bangalore. Payment for AMC will be on quarterly basis, after completion of each quarterly service and production of service voucher counter signed by the Warehouse Manager or In-charge of the respective Warehouse. Bill shall be certified by the Warehouse Manager. If the service provider fails to undertake servicing for a particular quarter, he will not be entitled for quarterly service (AMC) charges for the particular quarter. Not attending quarterly servicing will be treated as breach of agreement. No other charges will be paid for attending servicing / emergency call for repairs except the approved AMC rate.
13. **Validity** : Bid / Rate quoted shall be valid for one month.
14. **Tender acceptance/rejection**: The RM, CWC, RO, Bangalore shall have the right to reject all or any tender without assigning any reasons thereof.
15. **EMD/SD**: EMD of Rs.6,000/-& Security deposit Rs.15,000/- . An amount of Rs.6000/- shall be submitted towards EMD along with tender form. Tender without EMD will be summarily rejected. MSEs registered with the prescribed agencies are exempted from payment of EMD and should enclose the proof of their being registered with any agencies under Ministry of MSME. Successful bidder shall pay SD after adjusting EMD on award of AMC. The SD will be returned to the bidder after satisfactory completion of contract period, without any interest on SD.

16. **Last date:** for submission is 16.08.2022 at 03.00 PM. Bids will be opened on the same day at 3.30 PM in the presence of bidders who are interested to participate at their own cost at Regional Office, Bangalore.
17. **Agreement:** By the issue of communication of acceptance of quotation, the contract will come into force. Successful firm has to execute an agreement in the format on non-judicial stamp paper of appropriate value within 7 days from the receipt of acceptance.
18. **Eligibility Criteria:**
- a) Bidder shall submit a copy of Work order for having experience in the field of AMC of ELWBs either in CWC / FCI / any State Warehousing corporation for a minimum of 3 Nos. ELWBs for a minimum period of one year.
 - b) Hold valid license to undertake repairing and servicing of ELWBs in Karnataka in their name or through their associate partner (copy of license to be enclosed).
 - c) Submit copy of PAN card.
 - d) Copy of GST registration certificate.
 - e) Proof / MSME registration / UAM acknowledgement for availing EMD exemption.

Note : Bids without EMD (exempted for MSEs) and Non submission of any document above documents will be summarily rejected.
