#### TERMS AND CONDITIONS

- 1. Quotationer/bidder should have been registered with CPWD/Railways/MES/State PWD/other Government Organization/ Public Sector Undertakings & their Subsidiaries or having worked/ working with aforesaid Government Departments/ Agencies.
- 2. Security Deposit will be deducted @ 10% of gross amount of bill of the contractor which will be refunded after successful completion of defect liability period of 6 months. In case any defects are found within defect liability period, the same shall be repaired by the Contractor immediately at his own cost. EMD deposited alongwith the quotation shall be adjusted against the security deposits to be deducted from the bills of the contractor.
- 3. Quotationers/bidders should have completed successfully at least one similar nature of work i.e. "Any Civil Engineering Works" of value not less than Rs. 1.24 Lakh during the last four financial years (i.e. 2018-19, 2019-20, 2020-21, 2021-22) & current year (2022-23) up to the date of quotation submission.

# Note: It should be noted that credentials for the works executed for Private Organizations shall not be considered.

- 4. The sum total (arithmetic sum) of quotationer's turnover/revenue (income) from operations for the last three financial years (i.e. 2019-20, 2020-21, 2021-22) should be of value not less than **Rs. 3.18 Lakh.** The information shall be supported by CA certificate & audited Balance Sheets and Profit & Loss Statements of specified last three financial years. In case Balance Sheet and Statement of Profit & Loss for the immediate preceding financial year have not been prepared/audited, the account for one preceding financial year can be submitted.
- 5. Necessary taxes i.e. -Income Tax & other statutory taxes levied by Govt. time to time will be deducted from the bill as per prevalent rate as on date.
- 6. Quotationers/bidders shall quote their rates inclusive of GST, as applicable and GST will not be paid/reimbursed by CWC.
- 7. GST, Building or other construction workers cess or any other tax, levies, duties on materials and on complete works in respect of this contract shall be payable by the contractor and CWC will not entertain any claim what so ever in this respect. This should be included in the rates quoted by contractor.
- 8. The contractor shall be required to pay labour cess @ 1% of cost of construction work in accordance with each bill payable on account of such construction to the concerned StateGovt. (Labour Deptt.) Cost of material shall be outside the purview of cess, when supplied under a separate schedule items. CWC shall not entertain any claim whatsoever in this respect.
- 9. Contractor will have to arrange all labour, T&P etc. (at all levels) required for the execution/completion of the work as per site condition. Safety of working labour's lies on contractor only at all levels.
- 10. Items & Quantities given in the schedule are tentative to give an idea of work involved which may vary as per actual execution at site.
- 11. Work shall be executed strictly as per CPWD specification/Schedule. Work is to be completed within **Twenty days** from the date of issue of work order.

- 12. The Contractor will sign each paper of Quotations in token of acceptance of their offer.
- 13. The offer rate shall be valid for 60 days from the date of opening of quotations.
- 14. The time for execution of the work specified in the work order shall be deemed to be essence of the contract and the work must be completed within the specified period. If the contractor fails to complete the work within the specified period mentioned in the work order, the Competent Authority may at his discretion extend the date of completion and also consider levy of penalty as deemed fit based on the merit of the case.
- 15. In the event of any documents found forged/fabricated/tampered/ altered or manipulated, then the EMD of the Contractor would be forfeited and he would be debarred for participating in CWC for 5 years.
- 16. If, the work is not started by the contractor within 1/8th of stipulated time.

#### Or

The contractor having been given a notice in writing to rectify, reconstruct or replace any defective work or fails to complete the work within the stipulated date or persistently neglects to carry out his obligations under the contract and does not remedy it or take effective steps within 7 days after the notice, the Engineering-in-Charge shall have power to rescind the contract and the EMD, security deposit already deducted under the contract shall be liable to the forfeited.

- 17. No advance payment shall be made at any time and payment shall be made only after execution of items/work.
- 18. Before quoting the rates, contractor may visit the site.
- 19. The Contractor shall not sublet/assign the contract work to any other contractor.
- 20. The contractor will have to abide by the labour laws and have to extend the statutory due benefit to the person deployed and the CWC will not be held responsible for any compensation in case of any mis-happening during contract period.
- 21. Contractors submitting bid on behalf of a firm/Company must submit partnership deed or Certificate of Incorporation of the Company and Power of Attorney in the name of person signing the tender/quotation.
- 22. It is a works contract and there is no EMD exemption on account of MSME.
- 23. Contractor will upload the bank details (cancelled cheque).
- 24. CWC reserves the right to accept or reject any or all the quotations without assigning any reason thereof.

<u>Note:-</u>For deciding eligibility of NIQ, it is mandatory for the bidder to submit Financial turnover (Balance sheets with profit & loss account of specified proceeding three years) as per NIQ, similar nature of work experience certificates of requisite magnitude as per NIQ, failing which the quotation shall be summarily rejected.
