Sealed quotations are invited from reputed Service provider / Authorized service provider/ firms who wish to participate and qualify the following eligibility parameters in the NIT.

A. Eligibility Criteria:

- Bidder should have minimum one year experience of supplying of CCTV Surveillance system along with its accessories to state/Central/PSU/Autonomous reputed organization. (Copy of the work order to be attached).
- 2. Bidder should have completed at least 01 CCTV installation order of not less than Rs. 4 lacs.
- 3. Bidder should have a geographical presence/office in Gujarat related to subject concerned.
- 4. Successful tenderer shall submit Rs. 37500/- towards Security Deposit.
- 5. Bidder shall have GST registration and PAN Card in their name (Copy of the same shall be enclosed).
- 6. Tender form duly signed in all pages.
- 7. Declaration by the bidder.

B. NOTE AND OTHER DETAILS:

1. The bidder must fulfill all the above Sl. No. 1 to 5 of eligibility criteria and submit copy of the documents mentioned in Sl. No.1 and 5 along with technical bid. Those who fulfill the

above criteria will be declared as technically qualified bidder. The price bid of technically qualified bidders shall only be opened.

- 2. Security Deposit: Successful tenderer shall submit Rs. 37500/- towards Security Deposit within 05 days of the issuance of Purchase/ Supply order. No interest will be paid on the Security Deposit to the tenderer by the Corporation. The security deposit would be released on successful completion of the AMC period.
- 3. **Period of installation contract:** 28 days for installation of CCTV System for each warehouse. The date of commencement of installation work at Warehouses will be specified in Work order, which should be strictly adhered to. In case the bidder fails to complete the installation and commissioning, liquidated damages at the rate of 0.5% per week will be levied until completion of the work, not exceeding 10% of the contract value without any controversy/dispute of any sort whatsoever.
- 4. **Inclusions:** Service provider shall provide and maintain the entire CCTV Surveillance System in good working conditions for a period of one year. Any non-working units shall be replaced with an alternative unit towards substitute for smooth working and repair. (Camera and Power supply chord, NVR 16 Channels, Hard Disk, TV, Video Baloons, all minor parts included). The product shall carry a minimum of one year manufacturer/supplier warranty.
- 5. **Period of AMC**: The supply and installation of CCTV system at above mentioned Central Warehouses includes Two Year AMC. The period of AMC commences from the date of completion of successful installation. AMC covers 4 (four) quarterly visit of Service Engineer

(once in three months) for preventive maintenance service. Apart from routine visits on quarterly basis, the service provider has to attend on call basis any breakdown/defective servicing of CCTV at the centre. The provider has to deploy their personnel within 24 hours from the time of complaint. During repairs/replacement of any item, suitable substitute should be arranged by the party to avoid any disruption of CCTV service. In the event of failure to attend the repair within the scheduled time, penalty at Rs. 100/- per day till the date of attending would be recovered from the service provider. For having attended the Service Engineer has to obtain a signature on service report from the concerned Warehouse Managers. The Service Report need to be submitted to this office.

- 6. **Exclusions:** Cable, major parts, Camera, NVR, Hard Disk etc. Bidders must acquaint themselves fully with the locations of the Central Warehouses, before quoting the rate. He / she may consult with Warehouse Managers for inspecting the facility.
- 7. The sealed quotation containing Technical Bid and Price Bid shall be submitted on or before 20.08.2022 up to 3 PM to the CWC Regional Office, Mahalaxmi Char Rasta, Opposite Unnati Vidyalaya, Paldi, Ahmedabad-380007.
