## **ACCOUNTING CIRCULAR NO. #50**

Sub: Accounting of Poly Pallets purchased as part of "Research & Development" under the new accounting code 20850 POLY PALLETS (R& D)

Ref: Instructions issued by HoD ( PCS & Tech ) vide letter no CO/TQC/R&D/3/2021-2022 Dated: 17.12.2021 on Purchase of poly pallets and recycled plastic pallet under R&D.

- 1. Vide above instructions issued by HoD ( PCS & Tech)- copy enclosed, Poly Pallets are being purchased by all the regions of CWC as part of research & development.
- 2. For accounting of above, following instructions are advised to be followed:
- a. As per the Technical assessment given by the Technical Division of CWC, useful life of Poly Pallets(R&D) shall be **10 years with 5% residual value.**
- b. Poly Pallets (R&D) shall be accounted under the ledger "20850 Poly Pallets (R&D)" and provision for depreciation shall be created under the ledger "14850 Provision for Depreciation: Poly Pallets (R&D)". For this, following new ledgers have been created in Tally, ERP:

For Gross Value	20850 Poly Pallets (R&D)					
For Provision of Depreciation	<b>14850</b> Provision for Depreciation: Poly Pallets (R&D)					
For Charging Depreciation to P&L	<b>43171</b> Depreciation Poly Pallets R &D					

c. Both the Gross value and Provision of Depreciation of Poly Pallets (R&D) accounted under heads different than the above are advised to be shifted to the above new account heads by passing accounting entries.

With reference to above, it is observed that **19500** number of poly pallets have been purchased/supplied till **15.12.2021** and **14000** no of poly pallets have already been inspected and sent for lab testing. Another **2000** no of poly pallets are awaiting pre-purchase inspection while supply order has already been placed for **5500** no of poly pallets. As far as recycled plastic dunnage is concerned, **1000** no have already been inspected and the sample is being sent for lab testing, while **1250** no of recycled plastic dunnage are awaiting pre purchase inspection. Many Regions are also in the process of finalizing the bids (**Annexure I**).

It is unfortunate to note that **Kolkata Region** has neither floated any tender nor purchased any poly pallets / recycled plastic dunnage although having approval of **2,000 and 1,000** number respectively.

Vide letter dated 18.11.2021 (ref.2), it was advised to have performance study of all these pallets which would be exclusively used for stocks meant for long term storage, food grain in PEG Godown and for storage of FCI food grain in the contracts those have been awarded through GeM tender participation.

It is, therefore, advised to submit **Monthly Performance Report (MPR)** of the poly pallets and recycled plastic dunnage wherever purchased & being used and **expedite the purchase & inspection process** so that all payments could be made during this current financial year and the amount is booked under R&D-CAPEX expenditure.

This may the treated as Most Urgent.
