Sub.: Revision of storage tariff w.e.f. 01.04.2023 at Central Warehouses.....reg.

Sir/Madam,

In reference to this office letter No. CWC CO-CD0COST/4/2022-COMM dated 15.03.2023 regarding revision of tariff for FY 23-24 w.e.f. 01.04.2023, this office received feedbacks from Regional Offices which has been reviewed and the Competent Authority has finalized the tariff with few amendments in tariff circulated vide abovesaid letter dated: 15.03.2023. The tariff has been finalized for FY 23-24 based on recommendations/feedbacks received from RMs, taking into account the business scenario, market conditions and increase in establishment and operational cost, repair & renovation costs and other relevant factors.

1. The **Area Basis Tariff** for all existing warehouses has been revised in line with the recommendations of RMs, occupancy of the WHs, Depositors' profile and market rate in the locality. The Warehouse wise category, DWT Area Rates (Gross/Net) in Sq. ft., Special DWT Area Rates (Gross/Net) in Sq. ft., Bonded Rates (Gross) in Sq. ft. and Fertilizer Rates in MT are enclosed as **Annexure-I**.
2. The **Commodity wise Tariff** (Bag Basis) has been kept unchanged and all the commodities, whose tariff was fixed during FY22-23, have been included in the tariff. If any such commodity or any new commodity is received at the warehouses, the proposal for the same may be sent to CO for fixation of storage tariff accordingly. The revised Commodity wise tariff is enclosed as **Annexure-II**.
3. The **Special Commodity Tariff for Farmers & Traders** (Bag Basis) which was issued last year dated 14.09.2022 has been kept unchanged and all the commodities, whose tariff was fixed during FY 2022-23, have been included in this Special tariff. The Special Tariff is enclosed as **Annexure-III**.
4. Tariff for CCI Cotton Bales (Management and Hired WHs), Weighment Charges, Metals storage, Cold Storage Vashi, Ambad (Nashik) charges has also been revised and attached as **Annexure-IV**.
5. The Special Tariff for Wheat w.e.f. 01.04.2023 is enclosed at **Annexure-V**.
6. It has been noticed that in the inventory management of books, the establishment cost is higher than inventory management of other products stored under SDWT due to various varieties of books. Therefore, the tariff for '**BOOKS**' stored under

SDWT has been fixed and retained at 36% higher than DWT tariff as per **Annexure-VI**.

7. Preservation Charges shall be applicable as per this office letter dated 24.04.2023 attached as **Annexure VII**.
8. In case of utilization on Dedicated Warehousing Terms (DWT) being inbuilt annual escalation clause, the annual escalation of tariff as per the agreement shall continue to be applicable from due date (date of anniversary).
9. For the calculation of the storage charges the existing applicable tariff is on weekly basis in respect of stock received and delivered during the first month itself, i.e. for first week, it is 44% of monthly tariff, for two weeks, it is 68% of monthly tariff, for three weeks, it is 88% of monthly tariff and for four week and upto 30days, it is full monthly tariff; beyond first 30 days the weekly rate is 25% of monthly tariff. Month means a period of 30days. The minimum period for which storage charges are payable is one week (7 days).
The same has been revised and it has been decided by CA that now onwards the storage charges shall be charged on the basis of actual numbers of day's utilization instead of weekly basis. For the purpose of calculating number of days in respect of stock under storage, both the date of receipt and date of delivery are to be included while calculating the storage charges. A storage period of 30 days shall be considered as a month and for 30 days or multiple of 30 days monthly tariff shall be charged. For lesser number of days than 30 days the storage charge shall be calculated on day basis. For example:-
(a) If the stock is received on 15th April 2023 and either fully or partially delivered on 05th May 2023, the number of days utilized shall be (16+5) 21 days. The storage charges shall be calculated as under:
$$\text{Storage Charges} = (\text{Number of day's utilized (21)} \times \text{Number of Bags} \times \text{Monthly Storage Tariff}) / 30.$$

(b) If the stock is received on 15th April 2023 and either fully or partially delivered on 07th July 2023, the number of days utilized shall be (16+31+30+7) 84 days i.e. 02 Months (Period of 30 days means a month) and 24 days. The storage charges shall be calculated as under:
$$\text{Storage Charges} = [(\text{Number of Bags} \times \text{Monthly Storage Tariff} \times 2)] + [(\text{Number of day's utilized beyond two months (24)} \times \text{Number of Bags} \times \text{Monthly Storage Tariff}) / 30].$$
10. In order to rationalize/ decrease the number of warehouse categories, the high rated tariff categories where the number of warehouses are less, have been reviewed and warehouses falling in such category has been upgraded/downgraded depending upon the RM's recommendations, depositor profile and business aspect of the center. The Warehouse Categories have been revised to 11.
11. Bonded area tariff shall be applicable only for custom notified warehouses, if any Time Barred bond (TBB)/seized/confiscated cargo are lying in such warehouses those are not custom notified then the storage charges shall be applicable as per SDWT rates.

12. **FCI Gunny Bales:** Separate bills to be generated for food grain and gunny bales stored within reserved space. The bills for food grain stored will not attract GST, however, bills for storage of gunny bales in reserved space will attract GST.
For example; at any center FCI has reservation of 5000 MT and out of this 5000 MT capacity FCI stored 100 MT of gunny bales and 4900 MT of food-grain, in this scenario the separate bills will be raised for 4900 MT food-grain on reservation rates (without GST) and for 100 MT gunny bales on reservation rates (with applicable GST).
13. Storage/MF tariff for CFS/ICD/ICP/ACCs/RWCs may continue to be fixed for each center depending on its location, availability of business and quantum of competition. However, RM may send the proposal for revision of tariff if not considered/revised already. Under no circumstances the existing tariff will be continued beyond 01.04.2023 without CO approval.
14. Tariff with regard to FCI on guarantee basis is regulated by the Ministry, based on recommendations of Chief Advisor Cost (CAC), Ministry of Finance and the same shall be circulated as and when revised.
15. No rebate may be allowed without approval of Corporate Office except under DoP of RMs. The existing rebate of 10% to Co-operatives/ Agri Start-ups and 30% to Farmers i.e. bonafide agriculturist only for the storage of their products as per Para 7 of CO circular issued vide letter No. CWC-BD/II-Tariff/91 dated 13.01.1992 may be continued. Rebate on account of bulk storage, longer term storage and other special circumstances shall be decided on case-to-case basis with the prior approval of Corporate Office if it is beyond the DoP of RMs. Rebate already offered will continue till expiry of period agreed upon.
16. It may be ensured and confirmed that tariff of all the warehouses under your jurisdiction has been revised and implemented. Further tariff for any other general warehouse/commodity which has not been included in the revised tariff may be brought to the knowledge of CO for fixation/revision. If any center has been closed and still appearing in tariff, the same may be intimated to CO.
17. For those WHs, where SDWT tariff FY23-24 are lower than FY 22-23 tariff and there is any discount applicable to any depositor, the discount given to the depositors shall be discontinued.
18. For Hired WHs, where due to revised SDWT tariff FY23-24 the profit margin is not achieved, the financial viability of such centres may be reviewed by RMs and recommendation for category up-gradation should be submitted to CO for consideration.
19. Goods and Service Tax/any other tax as levied by the Central/State Govt. or local bodies, if any, will be charged extra wherever applicable, in addition to storage, insurance charges, weightment charges etc.
20. RM should bring out a booklet containing tariff for various warehouses/commodities in the Region and may communicate to concerned Warehouses/Depositors. It should also contain general terms and conditions for storage/delivery etc.

Precooling and Storage charges: Rs.3/- per kg per month plus Insurance charges @ Rs.0.05 per 100 Rupee value of stock per month.

Handling charges: Rs 6/- per kg. This includes Unloading at Pack house, Grading and Sorting charges, Packing charges and Loading the cargo into export container charges.

(Pomegranate)

Precooling and Storage charges: Rs.3/- per kg per month plus Insurance charges @ Rs.0.05 per 100 Rupee value of stock per month.

The storage charges are to be levied for minimum of one month and on monthly basis irrespective of storage period i.e. even if the stocks stored for 1 week, storage charges for entire month have to be levied.

Handling charges: Rs.5/- per kg. This includes Unloading at Pack house, Grading and Sorting charges, Packing charges and Loading the cargo into export container charges.

Other commodities: If any commodities are likely to be stored, the tariff for the same will be decided and published accordingly.

Note: The Cold Storage tariff for CFS Ambad (Nasik) is valid upto 30.09.2023.

D. CCI Management warehouses w.e.f 01.04.2023:

The tariff for CCI management charges has been fixed at Rs. 40.00 per MT/month (GST extra) for FY 2023-24 for CCI cotton bales.

For other management warehouses concerned Regional Office should submit a detailed proposal for fixing the revised rate of storage charges.

E. CCI Hired Godowns w.e.f. 01.04.2023:

The tariff applicable for own godowns will be applicable for hired godowns also in case of CCI but with a maximum cap of Rs. 66.83 per bales per month.

F. Lorry Weighment Charges w.e.f. 01.04.2023:

Rs. 67.79/-Per vehicle loaded/empty (excluding GST & other taxes applicable) for upto 10 MT vehicle. i.e. Rs 80.00/- per vehicle loaded/empty (including 18% GST applicable.)

Rs.135.59/- per vehicle loaded/empty (excluding GST & other taxes applicable) for above 10 MT vehicle. i.e. Rs 160.00/- per vehicle loaded/empty (including 18% GST applicable.)

G. Preservation Charges for DWT & S-DWT users:

Preservation Charges shall be applicable as per this office letter dated 24.04.2023 attached as Annexure VII.

H. Initial Fumigation Charges:

Initial Fumigation Charges shall be Rs.16/- per MT or Rs. 0.80 per 50kg bag applicable to all Warehouses.

I. Insurance Charge:

Insurance is to be charged separately except for food grains where the tariff is fixed including of insurance. Insurance charges may continue to be charged @ Rs.0.05 per 100 Rupee value of stock per month.

Sir/Madam,

Please refer this office circular No. CWC CO-CD0COMM/428/2021-COMM-Part(1) dated 29.11.2022 vide which, it was instructed that '*Fumigable stock e.g. Food grains, pulses, seeds etc. should be stored on bag basis as far as possible, however, the same may also be stored on area basis under DWT/SWDT basis wherever circumstances warrant with the prior approval of Regional Managers*' and during the storage of the stock CWC will mandatorily provide the preservation service.

This office vide letter No. CWC CO-CD0COST/4/2022-COMM dated: 15.03.2022 circulated the tariff for FY 2023-24 wherein it was mentioned that the preservation charges for DWT & S-DWT users will be communicated separately.

In this regard, Competent Authority has decided that wherever the fumigable stock is stored on SDWT basis, the preservation of the fumigable stock shall be done by CWC mandatorily and the SDWT (Fumigable Stock) Tariff shall be applicable which includes preservation charges. The category-wise SDWT (Fumigable Stock) tariff for FY23-24 is enclosed as Annexure-I. For non-fumigable stock the SDWT tariff shall remain same as circulated vide this office letter No. CWC CO-CD0COST/4/2022-COMM dated: 15.03.2022.

Further, in case fumigable stock is stored on DWT basis, depositors shall first approach to CWC for the preservation service and only on refusal of CWC, they may avail services of any other fumigating agency. CWC shall collect preservation charges i.e fumigation and spraying charges as per the actual service provided and rate for the services shall be collected separately as per PCS tariff applicable. The PCS tariff for FY 2023-24 has been circulated by Technical Division vide letter No. CWC/PCS/Correspondence/2022-23 dated: 29.03.2023.
