



## Definitions: -

“CWC” (**Central Warehousing Corporation**) is a prominent facility that offers comprehensive logistics services, including warehousing, container handling, and distribution. Located strategically to facilitate efficient transportation, CWC CFS ensures seamless management of goods from arrival to final delivery. With state-of-the-art infrastructure, advanced technology, and a dedicated team, the **facility** provides reliable and cost-effective solutions for businesses.

CWC CFS is committed to maintaining high standards of quality, safety, and customer satisfaction, making it a trusted partner in the logistics industry.

“**Container**” means the standard ISO marine container, suitable for transport and stacking of cargo and must be capable of being handled as a unit and lifted by a crane with a marine container spreader.

“**Hazardous Cargo**” shall mean any consignment with IMO classification listed as Dangerous Good (s) with a specific UN Class and UN Number. “**OOG**” shall mean “**Out of Gauge**” cargo shipped in Special Equipment like Flat Rack (Over Width and/ or Over Length and/ or Over Height), Open Tops (Over Height).

“**Over Dimensional Container**” shall mean a container carrying over dimensional cargo beyond the normal size of standard containers and needing special devices like slings, shackles, lifting beam, etc. Damaged containers and containers requiring special devices for lifting are also classified as “**Over Dimensional Container.**”

“**Per day**” shall mean per calendar day or part thereof.

“**Reefer**” shall mean any container for the purpose of the carriage of goods, which requires power supply to maintain the desired temperature. “**Port**” shall mean the Port of Mundra (INMUN).

“**Terminal**” means any Container Terminal within the premise of Mundra Port (Mundra International Container

Terminal Pvt Ltd. (**MICT**) (DP World)/ Adani Mundra Container Terminal (**AMCT**)/ Adani Mundra Container Terminal -2 (**T2**) / Adani International Container Terminal Pvt Ltd. (**AICTPL**)/ Adani CMA Mundra Container Terminal Pvt Ltd. (**ACMTPL**).

“**Ton, or, MT**” shall mean 1,000 (One Thousand) Kilograms.

“**Weighment Cycle**” shall mean full weighment cycle that comprises of weighment of the laden container on trailer or cargo laden truck followed by weighment of the container, or, empty truck, or, in the reverse order to determine the gross weight of the laden container or, cargo.



## General Points Governing the Tariff: -

- 1.1. Containers less than and up to 20' will be reckoned as one 20 feet container for the purpose of tariff.
- 1.2. All invoices are issued as due on presentation. Failure to pay may cause a lien to be placed on the goods handled at the CFS and the importer/ exporter may be denied further use of the CFS until all outstanding charges have been paid.
- 1.3. This tariff booklet should be read in conjunction with the CFS operating procedure, and this Tariff Booklet supersedes the earlier Tariffs as well as all earlier notified Tariff Modifications.
- 1.4. Tariff Applicability Rule: applicable on de- stuffing of import laden container or gate out of an import laden factory destuffing container and gate- out of all export containers with date of Bill of Entry/ Shipping Bill on, or, after **01<sup>ST</sup> Apr 2026**.
- 1.5. Container and cargo storage charges are calculated on a “per day” basis.
- 1.6. Weighing of import/ export loaded containers is mandatory as per the letter of the Assistant Commissioner (DP), CH: MP & SEZ, Mundra’s letter reference F. No. S/ DP- 08/ MPSEZ/ 2009, dated 22nd July 2009 and F. No. VIII/ 48- 01/ DP/MPSEZ/ 2011-12 dated 31st October 2011, respectively.
- 1.7. Charges for container longer than 40 feet will be charged twice that of a 20 feet container charges, wherever not explicitly specified.
- 1.8. Charges for empty lift on/off may vary from the actual tariff for some specific shipping lines.
- 1.9. Cargo storage charges are reckoned from the date of carting or de-stuffing to the date of stuffing, both days inclusive.
- 1.10. Any special services like dunnage/ lashing materials or, special equipment and/ or trailer for handling and/ or transportation will be charged additionally.
- 1.11. All Cheques/ DD to be drawn favouring “CWC” Central Warehousing Corporation Container Freight Station payable at Mundra. For payment by cheque, prior approval has to be obtained from the CFS Finance Department between 1000 to 1700 Hrs on any working day. Outstation cheques will be accepted subject to recovery of bank charges.
- 1.12. Prior to movement of export container or delivery of import cargo, the exporter, or importer must clear all the dues payable to the CFS.
- 1.13. GST and other statutory levies, wherever applicable, shall be charged extra at the prevailing rates at the time of billing.
- 1.14. Any spillage clean up charges accruing on account of handling of HAZARDOUS cargo, disposal of the HAZARDOUS. waste to a government approved waste handling facility, including transportation to such facility, shall be borne by the exporter/ importer.
- 1.15. In order to discourage malpractice, a dishonoured cheque shall invite an exemplary penalty of Rs. 5,000/- (Rupees Five Thousand Only) per cheque and/ or suitable legal action thereof.
- 1.16. All the Shipping Lines are advised to ensure that empty containers are surveyed prior gate– in for storage. After containers have been moved to storage yard, all requests for survey shall be chargeable as per applicable activity. .



- 1.17. It will be presumed that the stock being received at CWC-CFS, Mundra are adequately insured by the user against all possible risks during storage including interests of the Customs. Thus, in any eventuality, CWC/SAMO shall not be responsible for any insurable claims/risks including consequential losses. Same assumption will also apply for export cargo warehouses. However, in case the insurance cover is required by any party against the risk of fire, flood, cyclone, theft, etc., the same will be arranged by the CWC,CFS, Mundra on a written request, for which advalorem charge at the rate of 12.50 paise per `1000/- value of the stocks will be levied, per week or part thereof
- 1.18. Auction request to customs is to be made by CWC/ASAMO, hence there is no need for this narration. The storage charges on abandoned FCL containers/shipper owned containers shall be levied upto the date of receipt of intimation of abandonment in writing or 75 days from the date of landing of container, whichever is earlier subject to the following conditions :
- (i). The consignee can issue a letter of abandonment at any time.
  - (ii) If the consignee chooses not to issue such letter of abandonment, the container Agent/MLO can also issue abandonment letter subject to the condition that,
    - (a). the Line shall resume custody of container along with cargo and either take back it or remove it from the port premises; and
    - (b) the Line shall pay all port charges accrued on the cargo and container before resuming custody of the container.
  - (iii) The container Agent/MLO shall observe the necessary formalities and bear the cost of transportation and destuffing. In case of their failure to take such action within the stipulated period, the storage charge on container shall be continued to be levied till such time all necessary actions are taken by the shipping lines for destuffing the cargo.
  - (iv) Where the container is seized/confiscated by the Custom Authorities and the same cannot be destuffed within the prescribed time limit of 75 days, the storage charges will cease to apply from the date the Customs order release of the cargo subject to lines observing the necessary formalities and bearing the cost of transportation and destuffing. Otherwise, seized/confiscated containers should be removed by the Lines/consignee from the port premises to the Customs bonded area and in that case the storage charge shall cease to apply from the date of such removal
- 1.19. Movement of containers is subject to weight restrictions imposed by the Government, Court and other regulatory bodies. Overweight penalties imposed by RTO, etc, to be recovered from the Customs Broker/ importer/ exporter/ Billing Party
- 1.20. For export loaded containers, movement request submitted within 48 hours of vessel gate cut off / Pre-Gate cut off imposed by Line / Terminal may be subjected to SSR to be borne by the Customs Broker/ exporter. In case of congestion at terminals plan your consignment accordingly, CWC CFS will not be responsible for any shutout.
- 1.21. CWC CFS will not be responsible for any SSR charges levied by the port unless specifically agreed in writing by CWC.
- 1.22. For any reason (**except relinquishment as per customs guidelines**), if any export cargo is not cleared by the CB / Exporter, then the destruction cost will be on CB / Exporter account..
- 1.23. In import after vehicle loading, it should be moved out within 2 hours from the date of gate pass generation. Due to any reason vehicles are standing in CFS and creates obstacle in our day to day activity, then detention charges will be charged additional.



- 1.24. Claims if any will have to be made within 3(three) days from the date of incidence failing which no claims will be entertained. CFS reserves the rights to dispose the pallets after two days of actual cargo delivery taken by importer / CB and ground rent charges of that particular size of container will be collected from CB / importer in lieu of space occupied by empty pallets.
- 1.25. CFS reserves the rights to dispose the pallets after two days of actual cargo delivery taken by importer / CB and ground rent charges of that particular size of container will be collected from CB / importer in lieu of space occupied by empty pallets All disputes will be subject to Mundra jurisdiction only
- 1.26. Any leftover packaging material, post stuffing or delivery of cargo from CFS system, shall be kept with CFS till next 24hrs. No liability remains with CFS thereof.
- 1.27. The Owner (Importer/Exporter/CHA/Freight Forwarder) shall, at its own cost and expense, procure and maintain comprehensive marine and/or transit cargo insurance for the Cargo for its full insurable value against all risks of loss or damage, including while the Cargo is in the care, custody, or control of the Container Freight Station”
- 1.28. Where the Customer requests transport via standard trailer despite Port/CFS recommendation for Low-bed equipment, the Customer assumes all risks. Any liability for damage to cargo, container, or equipment shall be for the Account of the Customer.

CFS (dock) de- stuffing of import container activities include: transportation from MICT/ AMCT/ AICTPL/ ACMTPL/T2 to CWC CF CFS, grounding the loaded container for Customs examination, seal cutting on written request from the Customs Broker against Customs Permission+ valid original DO from the Shipping Line+ payment of relevant charges, de-stuffing of the container and direct delivery onto the Customs Broker nominated truck/ trailer. If the container is de- stuffed and the cargo/ commodity is stored in our warehouse/ yard for delivery at a later time, delivery onto trucks/ trailers will be effected on payment of SSR charges ( Rs.175 per MT). Delivery of cargo in domestic containers is subject to SSR charges.
- H. CFS (Factory) de- stuffing of import container activities include: transportation from MICT/ AMCT/ AICTPL/ ACMTPL/T2 to CWC CFS MUNDRA, lift- on/ lift- off, other in- yard activities, grounding for Customs examination and laden container delivery onto importer nominated vehicle.
- I. Any OOG consignment shall be priced on a case to case basis depending on the gross "out to out" dimensions (L X W X H) and the gross weight of the cargo including tare. OOG consignments have special handling requirements, and these can only be assessed after getting the dimensions, weight and proper engineering diagrams and photographs of the consignment.

- K. Loaded Containers carrying Hazardous Cargoes, Laded out of Gauge Cargo/Containers and Laded Special Equipments (Open Top, Flat Rack, and Flat Bed) shall be charged storage twice of Normal storage charges. For any back to town Container/Cargo no free days will be allowed.
