- Apropos, Corporation is undertaking Public Procurement through GeM/ e-Tenders/ NIQs etc., which mandates compliance of the guidelines issued & updated time to time by Government of India.
- Corporation vide above referred circular dated 19.01.2022 [copy attached] has already intimated all RO's & HOD's for publishing of details of Tenders/ EOIs/ SNIQs/ Auction Notice etc on website of Corporation. However, the guidelines are not being followed in toto.
- As per the guidelines stipulated under GFR clauses referred above, the Tenders/Limited Tenders/ NIQs/ EOIs/ SNIQs etc., are to be published on **CPP portal** as well as on the **website of the Corporation**, including the **details of award, mandatorily**.
- In this regard, vigilance division vide note dated 13.12.2018 has also instructed all RO's and HOD's to publish the details of contracts awarded above threshold value of **Rs. 10 Lakhs** on website of CWC.
- The format for publishing of tender may be referred from Circular dated 19.1.22 attached herewith.
- The format in which the award details are to be published is attached at **Annexure-1**.
- Thus, all ROs/ Divisions may please ensure to send the**
 - details of Tenders/Limited Tenders/ Single Tenders/NIQs/ EOIs/ SNIQs etc. and**
 - details of award above Rs 10 Lakh****to MIS Division, CO for updating the same on regular basis on website of the Corporation (integrated with CPP portal).**

1. All the tender notices/ EOIs/ SNIQs/ Auction Notices etc., are being uploaded on website of Corporation for ensuring wider publicity. Further, the tender portal is integrated with Central Public Procurement(CPP) Portal of Govt of India, which additionally ensures the wider publicity.
2. It is also pertinent to mention here that for uploading the tenders on website & CPP portal few details are mandatory, which was shared through aforementioned reference. Based upon these details, MIS Division hosts the tenders on website & CPP portal.
3. However, it is observed in some cases that the ROs & Divisions at CO are not sharing the format along with the tenders/ SNIQs/ EOIs/ Auction Notices etc, besides, **the concerned officials of ROs/ Divisions are not verifying the details of the tenders hosted on website.**
4. As such, it has been decided that **MIS Division shall not host** any tender/ SNIQ/ EOI/ Auction Notices on website **in absence of the stipulated format.** Thus, the ROs/ Divisions desiring to host tenders/ SNIQs/ EOIs/ Auction Notices etc. on website should mandatory share the format **in docx format** along with the tender notice in pdf format on warehouse@nic.in & lakshay.sharma@cewacor.nic.in .
5. The docx file of the format to be shared along with the tender notices/ SNIQs/ EOIs/ Auction Notices etc., can be downloaded from e-Office's Knowledge Management System (KMS). The user may click on KMS at the dashboard of e-Office & then may click on central documents. Thereafter, the user may type "Format for hosting tenders" in the search option available at the top for downloading the docx format. PDF format, however, is attached herewith for ready reference.

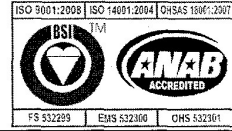
