#### EBT CIRCULAR #1

# Sub: <u>Financial Assistance Employee Welfare schemes for charitable purposes run by CWC Employees Benevolent Trust</u>

Board of Trustees of CWC Employees Benevolent Trust in its  $32^{nd}$  meeting held on 02.02.2023 has accorded its approval for revision of the Schemes for Financial Assistance to the employees for charitable purposes and same are as under: -

#### a) **Superannuation assistance scheme**:

The benefit of Rs. 60,000/- would be provided to the employees under "**Superannuation assistance** scheme" who superannuates from the services of the Corporation irrespective of the length of service on or after 01.04.2020 or who take voluntary retirement after completion of minimum 20 years of service in the Corporation on or after 01.04.2020.

#### **b)** Death Assistance Scheme:

The financial assistance of Rs. 2,00,000/- under the scheme would be provided in case of death of an employee during service on or after 01.04.2020, irrespective of length of service.

# c) Assistance to the employees with disability or having a dependent with Disability:

Assistance of Rs. 30,000/- per annum per dependant shall be provided to the employees with disability or having a dependant with disability. The disability shall have the same meaning as defined in section 80DD/80U of the Income Tax Act 1961. The employees shall furnish the claim application alongwith a copy of the certificate issued by medical authority in prescribed form and manner as is required to claim the deduction under section 80DD/80U of the Income Tax Act 1961.

The benefit would be paid to all employees who are on rolls of the Corporation as on 30<sup>th</sup> September of respective year, irrespective of length of service.

# d) Assistance to the employees diagnosed with critical disease or any of the dependant is diagnosed with critical disease: –

Financial assistance of Rs. 50,000/- (once during service) shall be paid to the employees who himself or any of the dependant has been diagnosed with any critical illness as defined in section 80DDB of Income Tax Act and applicable rules. The employees shall furnish the claim application along with a copy of the certificate issued by medical authority in prescribed form and manner as is required to claim the deduction under section 80DDB of the Income Tax Act 1961.

The benefit would be paid to all employees who are on rolls of the Corporation as on 30<sup>th</sup> September of respective year, irrespective of length of service.

#### e) Financial assistance to promote Yoga, Fitness & Healthy lifestyle for self and dependent:

Financial assistance of Rs. 15,000/-per annum shall be provided to promote yoga, fitness & healthy lifestyle for self and dependant. All the regular employees of the Corporation would be paid the above amount without any certificate.

The assistance would be paid to all existing employees who are on rolls of the Corporation as on 30<sup>th</sup> September 2022, irrespective of cadre/grade.

## f) Reward for outstanding performance for Class X,XII, Bachelor/Master degree student scheme:

The children of the employees who are having outstanding performance in Class X, XII, Bachelor & Master degree (children securing more than 85% marks or 9.0 CGPA) would be awarded Rs. 5,000/- per child.

The above scheme is only applicable for UGC approved courses for the Bachelor/Masters degree. The benefit would be paid to dependents of all employees who are on rolls of the Corporation as on 30<sup>th</sup> September of the respective year.

### g) Financial assistance for protection of environment and promotion of culture scheme :

The employees of the corporation would be provided a financial assistance of Rs. 5,000/- to all the employees on roll of the corporation for promoting environment (for plantation, proper waste management, sanitation, avoid use of plastic) and promotion of culture.

The assistance would be paid to all existing employees who are on rolls of the Corporation as on 30<sup>th</sup> September 2022, irrespective of cadre/grade.

- 2. The benefits under above schemes would be reviewed by the Trust every year.
- 3. The application for assistance under scheme at (c), (d) and (f) of para 1 above would be provided on submission of claim form in the prescribed form.
- 4. The assistance under financial assistance to promote yoga, fitness & healthy lifestyle for self, dependent, and financial assistance for protection of environment and promotion of culture scheme would be paid by the trust without any claim form.
