EBT CIRCULAR # 2

Sub: Loan Assistance Employee Welfare schemes for charitable purposes run by CWC Employees Benevolent Trust

Ref. (i) Circular No. CWC CO-FD0EBT/11/2020-FIN dated 17.02.2021

Board of Trustees of CWC Employees Benevolent Trust in its 32nd meeting held on 02.02.2023 has accorded its approval for revision of the schemes for loans to the employees for charitable purposes and same are as under:-

(a) Marriage Loan scheme

The amount of Rs. 3,00,000/- under Marriage Assistance Scheme would be provided to the employees w.e.f. applications for loan applied on or after date of circular for the marriage of self and any dependent. The interest rate applicable will be 6% per annum. The loan amount (including interest) would be recovered in maximum 36 monthly equal instalments (EMI). The loan will be recovered in 36 equal instalments or earlier depending upon the remaining service of the employee.

Other terms and conditions will remain unchanged as per above mentioned circular

(b) Higher Education loan scheme

The Board of Trustees of CWC Employees Benevolent Trust had decided in their meeting held on 22nd Jan, 2021 to start a new scheme, with the name of Higher Education loan scheme. The employees as on date on pay roll of the Corporation shall be entitled for this loan. A loan upto Rs. 5.00 lakh per child/dependant during the course of higher education (in single instalments) for self or any dependant family member as defined in section 80E of the income tax Act 1961 would be provided to the employees. The interest rate applicable will be 6% per annum. The loan amount (including interest) would be recovered in maximum 60 monthly equal instalments. The loan would be paid based on the total fee payable to such educational institute.

(c) Education Loan Scheme for girl child:

The Education Loan for girl Child would be provided to the employees on the terms & conditions as given below:

- (i) All the regular employees who have completed one year of service in the Corporation can avail refundable education loan for girl child (From KG to Class XII) with @ 6% per annum.
- (ii) The amount of loan to be given under this scheme is Rs. 1,00,000/- will remain unchanged.
- (iii) The amount of Loan will be recovered in 24 equal instalments (EMI) or earlier depending upon the remaining service of the employee.

 - (ii) **Higher Education loan scheme -** The employees as on date on pay roll of the Corporation shall be entitled for this loan and can avail refundable education loan for child/ dependant during the course of higher education (in single instalments) for self or any dependant family member as defined in section 80E of the income tax Act 1961.
- 2. The ceiling of **Education Loan Scheme for girl child** will be Rs.1,00,000/- for courses up to 12th class.
- 3. The ceiling of **Higher Education loan scheme** will be Rs. 5,00,000/- for courses of higher education as defined in section 80E of the income tax Act 1961
- 4. The rate of interest of **Education Loan Scheme for girl child** and **Higher Education loan scheme** will be 6% per annum on EMI basis.
- 5. **Education Loan Scheme for girl child:** The amount of Loan will be recovered in 24 equal instalments (EMI) or earlier depending upon the remaining service of the employee.
- 6. **Higher Education loan scheme:** The amount of Loan will be recovered in 60 equal instalments (EMI) or earlier depending upon the remaining service of the employee.
- 7. Applicant has to submit self-attested (by employee) photo copy of last Exam Passed by the child.
- 8. Applicant has to submit self-attested photocopy of proof of studying/admission/offer letter for admission/undertaking by the applicant.
- 9. Incomplete application form will not be entertained.
- 10. Loan can be granted for maximum Rs.1,00,000/- for Education Loan Scheme for girl child and Rs. 5,00,000/- for Higher Education loan scheme subject to availability of funds.
