 M/s Sparsh Hospital, Infantry Road is having IT exemption certificate for <u>Fracture in any part of the skeletal system or dislocation of vertebrae requiring</u> <u>surgical operation or Orthopedic treatment</u>. Other than the above treatment, the medical expenditure will be added as perks in the hands of the employee.

In all the cases requiring Indoor treatment as referred to by the attending Doctor, the Authorization letter will be issued by the Regional Manager/Establishment Section, RO Bangalore in the case of RO and Warehouse Employees. The Employees of the Corporation serving in other region shall also obtain authorization letter from RO, Bangalore.

All the employees of the Corporation irrespective of cadre and their dependent family members duly authorized by this office are entitled to avail treatment from the above hospitals as in-patient.

The Employees and their dependents shall get admission in the Hospital on production of Medical ID card/CWC ID Card in case of emergency. On the next working day, authorization letter issued by the designated Officer shall be submitted in favor of the employees and/or their dependents to regularize admission.

Further, before the final discharge of the patient all the documents including bills must be got signed by the Hospital from the employee dependents as the case may be.

The claims forwarded by the Hospital Authority shall be settled by the Accounts Department RO, Bangalore for the staff of RO/Warehouses.

The contents of this circular may be brought to the notice of all the officers/staff.
