CIRCULAR

Sub: Submission of Annual Contribution under Post Retirement Medical Re-imbursement scheme by retired employees/spouse of deceased employees for F.Y. 2020-21

(i) Circular No. No. CWC/PRMB/Trust meeting/2019-20 dated 12.03.2020, 16.03.2020 & 24.03.2020

Apropos above, references have been received to extend the date of submission of application for PRMB and annual contribution due to lock down of the country due to Corona Covid - 19.

- 2. The date of submission of application and annual contribution is extended to 20.04.2020. However, ex-employees should try to submit the application and contribution at the earliest possible so that their name can be forwarded to the insurer.
- 3. A self certified living certificate in prescribed format (Annexure -I to circular dated 12.03.2020) would also be acceptable in view of the difficulty being faced by ex-employee in getting the certificate from the prescribed authorities due to Corona Covid-19. However, this is a one-time dispensation and should not be quoted as a precedent.
- 4. The ex-employees who did not avail the benefit of the scheme during previous years and wish to avail the benefits of PRMB scheme now, shall submit a written application on the email id: prmbopdcwc@gmail.com mentioning the reasons for non-availment of the benefits during previous years along with following documents.
 - Copy of the valid retired employees identity card, (i)
 - (ii) Living certificate as per prescribed format,
 - (iii) Declaration by employees who took VR/SVRS (who have not attained the age of 60 years).
- Application received as per details under para 4 above would be verified and after verification their details would be uploaded on the PRMB
