CIRCULAR NO.19/2023-PRMB

Sub: Reimbursement of outdoor medical expenses in respect of retired employees for the period 05.04.2023 to 04.04.2024.

Ref. Circular no. CWCCO-FD0PRMB/9/2022-FIN, Dated : 31.03.2023.

1. With the approval of the chairperson of PRMB Trust in its 12th meeting held on 05.09.2023, the reimbursement of outdoor medical expenses has been revised from Rs. 15,000/- p.a to Rs. 30,000/- p.a for retired employees. Retired employees who are member of PRMB scheme for the period 05.04.2023 to 04.04.2024, may submit their application after incurring expenditure of Rs.30,000/- as reimbursement will be restricted to Rs.30,000/-per annum & in one installment for reimbursement of outdoor medical expenses incurred for self and dependent spouse as per prescribed form enclosed (Annexure-1) in online mode through PRMB software only as per enclosed User Manual (Annexure- II) .

2. All payments will be processed by CWC PRMB Trust at corporate office only and amount will be credited directly to the bank account of retired employee which was mentioned at the time of submission of PRMB base policy form. No Regional office shall make payment to retired employees on account of outdoor medical treatment.

3. The payment to the retired employees would be made as under: -



- Login for PRMB Link Present on the page.



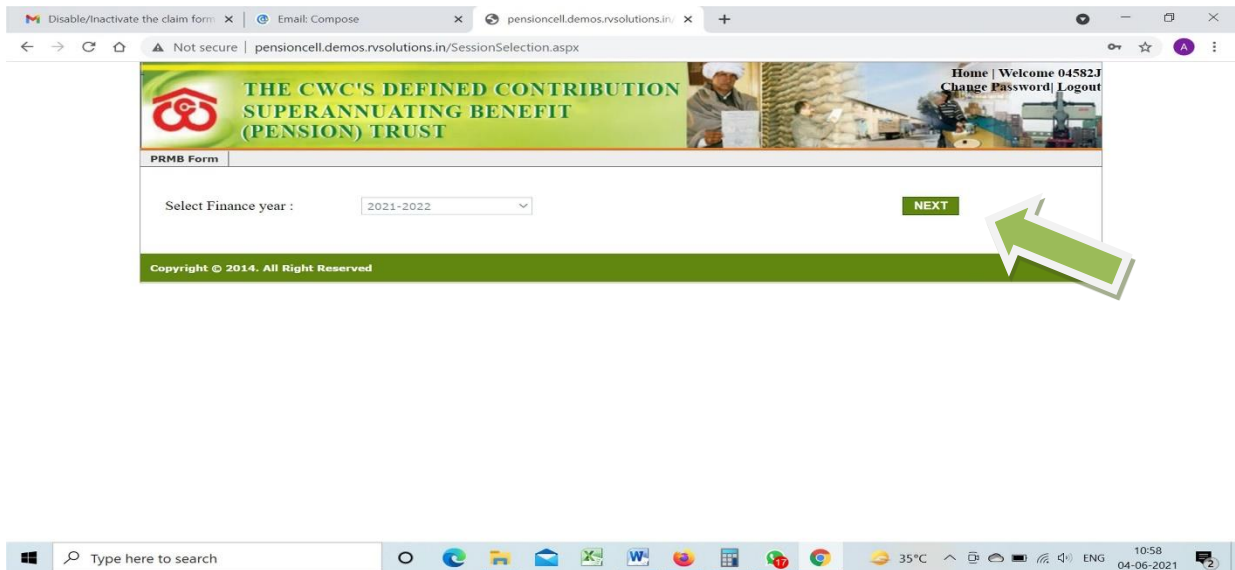

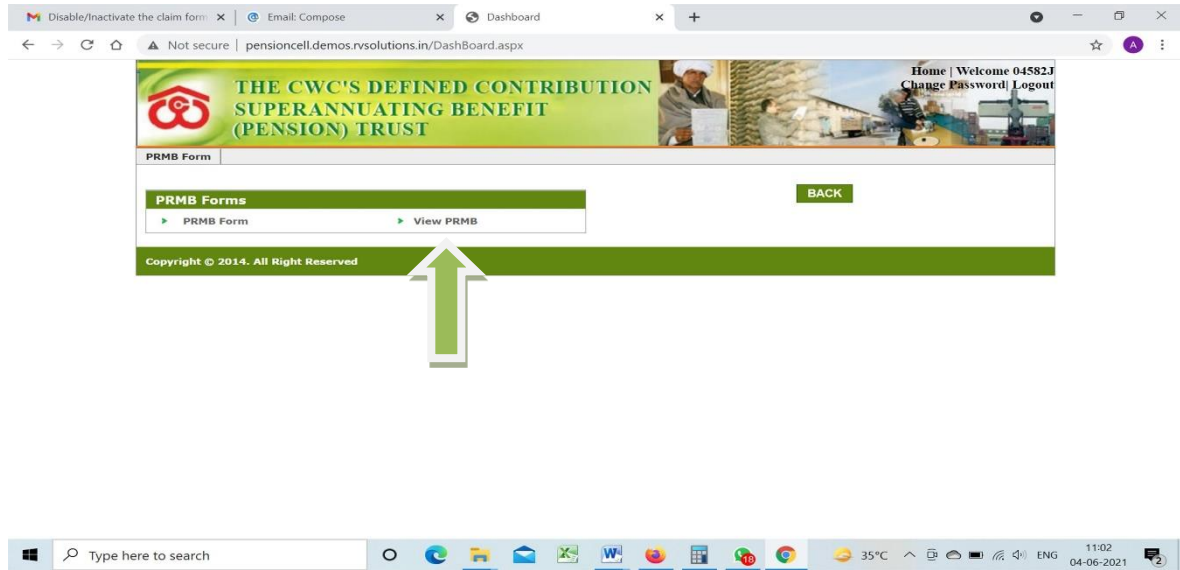
2. User Dashboard

Fill the Application for Reimbursement of Expenditure Incurred on Outdoor Medical Treatment by Retired Employees:

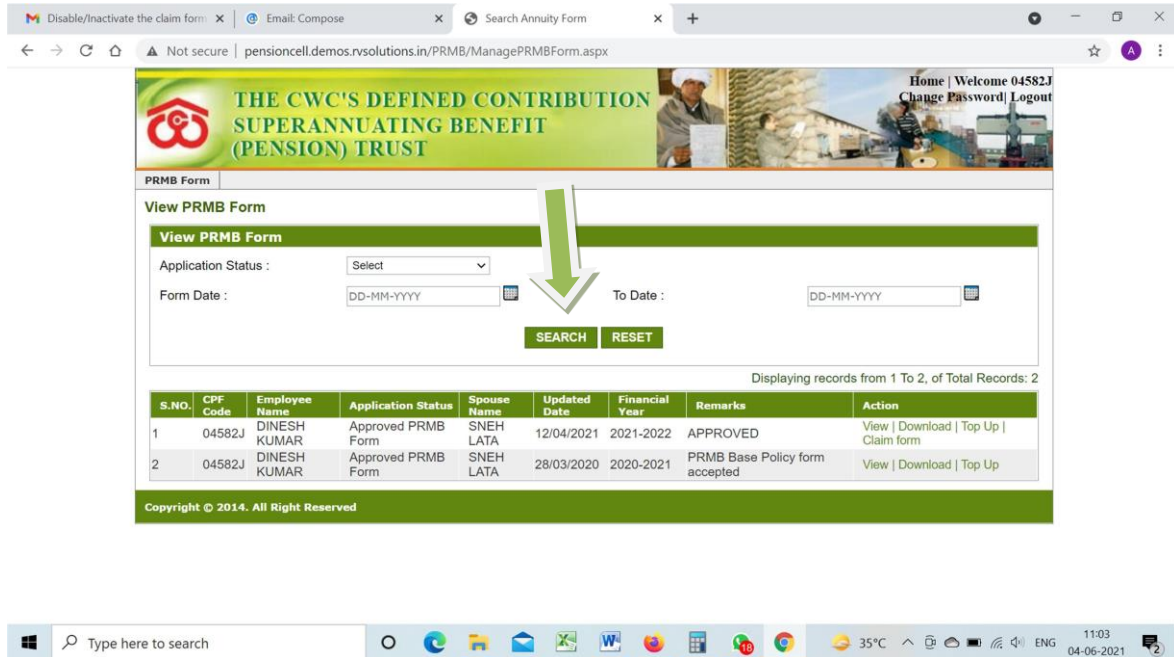

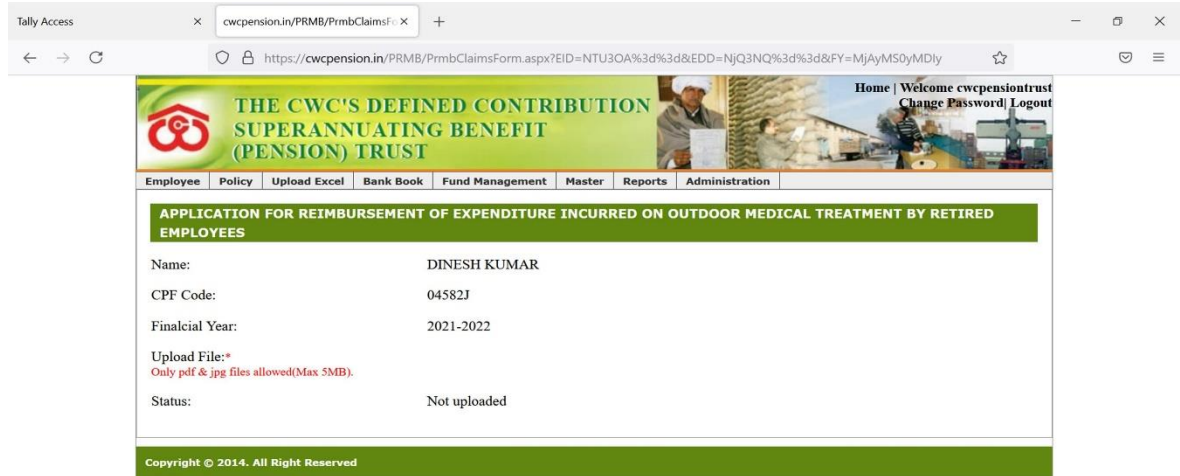


(d) On Clicking the “**View PRMB** ” this window will be open:
