Sir,

With the approval of Competent Authority, your hospital have been empanelled for a period of one (01) year with immediate effect subject to extension for another one year on the sole discretion of the Regional Manager, Central Warehousing Corporation, Jaipur for indoor treatment of employees and their dependents on direct payment system. The facility may also be extended to Ex-employees of CWC and their spouse also on the same rate but on cash payment basis. The terms & Conditions of Empanelment of hospital will be as follow:-

The OPD treatment charges will be collected by you from the individual concerned.

The following are the terms and conditions regarding empanelment of your hospital.

The employees and their dependents will be referred to your hospital for indoor treatment with an authorization letter issued by the Corporation duly signed by the concerned officer. If it happens to be a holiday, or in an emergency case, the patient concerned can be admitted immediately on the strength of their identity cards and the authorization letter can be produced on



the following working day the employee before discharge of the patient till that time the patient will be admitted for the treatment. The employee of the Corporation who are working in other regions may also be referred to the hospital for indoor treatment by this office.

Admission is to be made in the hospital as per the entitlement of the room rent prescribed in the authorization letter by the Corporation. The authorization letter shall be issued for indoor treatment on the recommendation of the concerned doctor of the hospital and not for the investigation, diagnostic procedures etc.

During the time of admission preference will be given to the employees / their dependents of the corporation.

The indoor treatment for the employees and their dependents may be taken for illness of specialized diseases, which cannot be treated at OPD.

Bills will be settled within three weeks from the date of its receipt and the payments will be released directly to the hospital by the Accounts Division, CWC, Regional Office, Jaipur.

Before the final discharge of the patient all the documents including bills must be got signed by the Hospital authorities from the employees / dependents as the case may be.

The contract can be terminated by either side by giving 30 days' notice without assigning any reason for which the hospital will have no claim for any compensation / damages whatsoever on this account.

The hospital would provide our employees / their dependents medicines and all other necessary items / facilities which are generally required for the best treatment of the patient except inadmissible items like cosmetic etc. from their stores since as per our policy officials are not required to purchase medicines while admitted in the empanelled hospitals.

In case, Hospital does not have provision to supply blood / blood products from their hospital, the patient / party may procure the same from market / blood bank and cost of the blood / blood products may be got reimbursed from Hospital on the spot on the basis of the bills for onward claiming of bills by the Hospital on CWC.

Where the hospitals has charged CGHS NABH / NABL rate the same shall be paid to the hospital after obtaining a certificate from the empanelled hospital that they are accredited to such categories. Alternatively it can also be verified from CGHS website. This may be ensured by all concerned.



In case, any deviation in the terms and conditions already agreed by you, the hospital shall be de-barred from the panel of the Corporation.
