SHORT TERM LIMITED QUOTATION INQUIRY

The Regional Manager, CWC, RO, Lucknow invites Limited Quotation from Reputed Manufacturer/Service Provider having valid "License" for repairing of ELWB in the state of UP for shifting of the existing functional 16x3 Mtr., 60 MTC ELWB and modifying the platform size to 12X3 mtr size 60 MTC ELWB at Central Warehouse, Hardoi from its existing place to the new designated place within the warehouse premises as per the following terms & conditions.

1. The quotation must be accompanied with EMD of Rs. 5000/- in the form of Demand Draft from any scheduled bank favoring 'The Regional Manager, Central Warehousing Corporation' payable at Lucknow.
2. An amount of Rs. 25,000/- would be retained as SD amount for the said work during the currency of warranty period. The EMD would be adjusted against the SD.
3. The sealed envelope containing Quotation should be super-scribed " Quotation for shifting of existing functional 16 x 3 mtr platform size ELWB and modification to 12 x 3 mtr platform size 60 MTC ELWB". The main envelope should contain the sealed envelop of Price Bid.
4. Quotations can be sent by post/courier or be delivered by hand in time. For any late receipt/wrong delivery, the Corporation will not be held liable.
5. Small Scale Units registered with the National Small Industries corporation under revised scheme who can produce certificate of competency for manufacture of the above said stores from NSIC will not be required to submit the requisite Earnest Money up to the monetary limit fixed by the NSIC. Quotationers should furnish requisite amount of earnest money with the Quotation beyond monetary limit fixed in the registration certificate by NSIC. This concession will not be available to the parties who do not furnish Registrations and Competency Certificate mentioned in the paragraph.

GENERAL TERMS & CONDITIONS

- ⇒ The civil work includes raising columns for installation of 6 nos. of load cells, construction of ramp of 6 mtrs on both sides of the ELWB platform and concreting of platform length but excludes that of ELWB cabin.
- ⇒ **Rate should be quoted in enclosed annexure-II** inclusive of all taxes but exclusive of Service Tax, if any and should be submitted in a Sealed cover which would be part of main envelope.
- ⇒ The service provider is to offer one year warranty on the work undertaken by him for any defects which will be attended free of cost during the said period. The date of warranty would commence from the actual date of handing over of the ELWB.
- ⇒ An amount of Rs. 5000/- is to be deposited in the shape of Demand Draft favouring the Regional Manager, CWC, Lucknow drawn on any scheduled bank payable at Lucknow towards EMD amount.
- ⇒ An amount of Rs. 25,000/- would be retained as SD amount for the said work during the currency of warranty period. The EMD would be adjusted against the SD.
- ⇒ The time period allowed for completion of the entire work is 20 days only which may be extended by further period of not more than 10 days under exceptional circumstances citing valid reason in writing by the party. It would be the discretion of the Regional Manager, Lucknow to extend the period .
- ⇒ The '**General Terms & Condition**' along with the quotation accepting all terms & condition should be submitted with the Quotation. **Conditional offer would not be accepted and is liable for Rejection.**
- ⇒ The party should also enclose the valid repairing & servicing license of ELWB issued from the appropriate authority.
- ⇒ The party should also submit a copy of PAN and Service Tax Registration Certificate along with the quotation.
- ⇒ Performance certificate issued from at least one client for similar work/conversion of Mechanical/Electro Mechanical Weighbridge to ELWB in respect of at least one ELWB should be enclosed.
- ⇒ In the event of tie of the offer between two parties, the party with maximum experience would be given priority.
- ⇒ In the event of any dispute arising out of conversion of LWB the decision of Regional Manager, CWC, R.O. Lucknow shall be final & binding on both the parties.
- ⇒ Regional Manager, CWC, RO, Lucknow reserves the right to terminate the contract at any point of time without assigning any reasons thereto which would be final and binding on the part of the service provider
- ⇒ Payment will be arranged by Regional Manager, Central Warehousing Corporation, Regional Office, Lucknow on receipt of pre-receipted bill induplicate along with satisfactory work completion certificate from the warehouse manager, CW, Hardoi.
