विषय:डबल्यूएमएस में बिल बनाते समय Rate/Tariff editing बंद करने बाबत।

आप सभी को यह सूचित किया जाता है कि डबल्यूएमएस में रिज़र्वेशन के बिल बनाते समय Rate/Tariff की editing की सुविधा उपलब्ध थी जिसको बंद करने के लिए सभी क्षेत्रीय कार्यालयों द्वारा ईमेल दिनांक 1.4.2022 द्वारा सुझाव मांगे गए थे। जिसके एवज में 8 क्षेत्रीय कार्यालयों द्वारा सुझाव प्रस्तुत किए गए ।

उन सभी जवाबों को पढ़ने पर निम्नलिखित कारण सामने आए:

- कुछ cases में सीडबल्यूसी depositor को स्पेशल टैरिफ ऑफर करती है जो कि सीडबल्यूसी के published टैरिफ से अलग है।
- कुछ cases में सीडबल्यूसी depositor के साथ एग्रीमंट करती है जिसमें escalation क्लॉज़ एग्रीमंट anniversary की date से चलता है।
- कुछ Civil Supply कार्पोरेशन अलग रेट देती है जो कि FCI current रेट या FCI old रेट होता है।
- गेल gas को SDWT टैरिफ लागू होता है परंतु वह DWT टैरिफ की पेमेंट कर रहा है जिसके चलते भंडारगृह प्रबन्धक रेट बदल कर DWT का रेट लगा रहे हैं।
- Mezzanine फ्लोर के टैरिफ डबल्यूएमएस में कॉन्फ़िगर करने का provision नहीं है जिसके चलते रेट बदल कर बिल बनाया जा रहा है।

इन सभी कारणों को निगमित कार्यालय द्वारा जांचा गया एवं प्रत्येक क्षेत्रीय कार्यालय एवं भंडारगृह के कारण के सामने बिना रेट बदले सही बिल बनने के उपाय को संलग्न document में लिखा गया है ।

सक्षम अधिकारी की अनुमित से दिनांक 29.04.2022 से डबल्यूएमएस में Rate/Tariff editing बंद की जा रही है। अब यह editing केवल Delivery basis bill में ही उपलब्ध होगी जिसे भी जल्द ही सभी क्षेत्रीय कारयालयों द्वारा सुझाव मँगवा कर बंद करवाया जाएगा।

आप सभी से निवेदन है कि जहां भी पार्टी को published tariff से अलग rate चार्ज करना है वहाँ निगमित कार्यालय के Commercial विभाग से special tariff को डबल्यूएमएस में configure करवा लिया जाये ताकि बिल सही rate से बन सके।
