As per Existing DOP of MD at S. No.67(a), Managing Director has Full powers for Purchase /Lease of land/ warehouse/ godowns etc. as under :

The **Board in its 379<sup>th</sup> meeting** on 17.02.2023 has approved the proposal to modify this DoP for **inclusion of license** of land, warehouse/godowns etc apart from purchase/lease and inclusion of **PSEs & Statutory Corporations** apart from local bodies/ State/ Central Govt./ Port Trust and marketing committee from which purchase/lease/license of land, warehouse/godowns etc. can be made.

Accordingly, **the modified DOP clause** no.67 (a) for purchase/lease/license of land, warehouse/godowns etc is as under :
