ELIGIBILITY CRITERIA:

The consultant who fulfills the following requirements shall be eligible to quote the rates.

A) Mandatory Documents

1. EMD, Cost of Tender & Tender Processing Fees:
Contractor must submit the following:
 - (a.) The EMD to be paid in favour of Central Warehousing Corporation, New Delhi only through e-payment gateway of e-procurement and receipt of the same should be scanned and uploaded on the e-tendering website www.cwceprocure.com along with e-tender documents.
 - (b.) Tender processing fee (non-refundable) would be paid mandatorily to M/s ITI Ltd. through e-payment through the portal www.cwceprocure.com.
2. **Other Mandatory Documents:**

Quotationer shall have a valid Certificate of Registration/Accreditation with National Accreditation Board for Education and Training (NABET). The Quotationer is explicitly required to provide the certificate of registration/Empanelment to ascertain their eligibility.

NOTE - The Consultant not fulfilling the above requirement of mandatory documents or submission of clarification with respect to mandatory documents shall be summarily rejected. It may also be noted that there is no exemption of EMD to MSME bidders.

INSTRUCTIONS TO SUBMIT ONLINE QUOTATION

1. The interested and Eligible Parties/bidders/Consultants should submit all the required mandatory documents, as described in Annexure-1 (Eligibility Criteria).
2. The QUOTATION without mandatory Documents as described in Annexure-1 (Eligibility Criteria) shall be summarily rejected.
3. The interested and Eligible Parties/bidders/consultants are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their QUOTATION as to the nature of ground, the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their QUOTATION.

4. QUOTATIONS containing any condition leading to unknown/indefinite liabilities shall be summarily rejected.
 5. Quotation bid would be opened at due date and time mentioned in NIQ and the same would be examined by the committee of the CWC officers. In the event of any of the documents found fabricated/tempered/forged/altered/manipulated/ false during the evaluation of bid at any stage, it will lead to rejection of the bid. CWC reserve its rights to disqualify the bidder and to blacklist/ debar for future participation for the next five years.
 6. In the event of any of the documents found fabricated/ tempered/ forged/ altered/manipulated/false, which was submitted by Bidder to claim his eligibility for acceptance of his QUOTATION, even after the award of the contract, it will lead to termination of the contract, forfeiture of Performance Security/ Security Deposit whichever is available at the time of termination.

CWC reserve its rights to disqualify such bidder and to blacklist/ debar for future participation for the next five years.

7. The bidder or their authorized representative who may wish to be present, may attend the opening of the quotation.
8. The Bidders shall quote their rate inclusive of GST & all statutory levies, any other taxes, levies, duties as applicable on complete work, after study the relevant clauses of Applicable ACTS, Rules and Regulations of State and Central Governments. CWC will not entertain any claim what so ever in this respect.
9. Under Income Tax Act, 1961, a deduction for income tax along with surcharge as applicable will be made from sums paid on account and final payments for carrying out the work under this contract.
10. The Bidder shall not increase his/their rates in case CWC negotiates for reduction of rates. Such negotiations shall not amount to cancellation or withdrawal of original offer and rates originally quoted will be binding on the Bidders.
11. Work shall be awarded to L1 bidder (among all qualified/technically accepted Bidders) only who has quoted lowest total amount calculated based on item rates quoted separately for each sections/Subheads.
12. Since this is indivisible work. There will be no splitting of Work. There will be no Counter Offer to L2/L3/MSE etc. bidder.
13. The Bidders shall be responsible for arranging and maintaining at his own cost all materials, Primary and secondary services, reference technical documents, tools, Computer machines, Stationaries, Printers, plants, water, electricity access, facilities for workmen etc. for executing the work unless otherwise specifically provided for, in the contract documents.
14. The contract operations and proceeding in connection with the works at all times be conducted during the continuance of contract in accordance with the laws, or finances, rules and regulations for the time being in force and the Bidders shall further observe and comply with the bylaws & regulations of the Government of India, State Government, local Municipalities, Railways and other authorities having jurisdiction over area involved in connection with the works of site & over operations such as those as carried out by the Bidder/s and shall give all notices required by such by laws & regulations. The hospital and medical regulations in

force for the time being shall also be complied with by the Bidder/ Bidders and his workmen.

The consultant shall abide themselves and shall be responsible to follow the relevant rules and regulations framed/ notified by State / Central Government concerned and applicable ACTS as amended by them from time to time.

The Consultant shall at all-time keep the CWC indemnified against all penalties that maybe imposed by the Government of India or State Government for infringement of any clauses of the above ACTS and RULES made there in by STATE/Central Government Concerned.

15. If the Consultant expires after the submission of his QUOTATION or after the acceptance of his QUOTATION, the CWC shall deem such QUOTATION as cancelled. If a partner of a firm expires after the submission of their QUOTATION or after the acceptance of their QUOTATION, the CWC shall deem such QUOTATION as cancelled, unless the firm retains its character.
16. No Engineer employed in Engineering or Administrative duties in Engineering Division of the Corporation is allowed to work as a Contractor/Consultant and also an employee of Bidder for a period of two years after his retirement from Corporation service, without the previous permission of the Central Warehousing Corporation in writing. This contract is liable to be cancelled if either the Bidder or any of his employees is found at any time to be such a person who had not obtained the permission of the Central Warehousing Corporation as aforesaid before submission of the QUOTATION or engagement in the Bidder's service.
17. The Contract to be finalized against this enquiry shall be an item rate contract and the rates once accepted by CWC shall be invariable and fixed.
18. Validity of Rates shall be 60 days from the date of opening of technical bid.
19. CONSULTANT shall be well versed with region geological, geographical, economical and metrological environment. Address of Project Location is below.

TERMS & CONDITIONS:

1. The consultant is hereby informed to visit the site and as per scope of work shall provide following services as mentioned below:

A. Renewal of Consent to Operate (CTO) from State Pollution Control Boards under section 25 & 26 of the Water (Prevention & Control of Pollution) Act'1974 & under section 21 of the Air (Prevention & Control of Pollution) Act'1981.

2. The scope of work includes:

Environment Consultancy Services required to Renew Consent to Operate (CTO) Authorization from State Pollution Control Boards in favour of Central Warehousing Corporation for RWC Agra Terminal/Warehouse for 05 years as per the criteria and guidelines of UPPCB.

- Preparation of project report and checklist (If required) in consultation with SPCB for Renewal of, Consent to Operate Authorization;
 - Analysis and submission of the data received from concern department;
 - Preparation and submission of Application to SPCB online/offline (Consent to Operate Authorization);
 - Discussion and liaison with the SPCB Regional and/or Head Office;
 - Presentation to SPCB as may be required; and
 - Obtain Renewal for Consent to Operate Authorization from SPCB. Any other detail necessary to execute the designing will be provided by CWC to the consultant as and when required.
3. The EMD deposited at the time of bid submission will be returned after the Renewal for consent to operate (CTE) authorization is received from SPCB/UPPCB.
 4. CWC Will pay any and all official charges/Fees (if any) pertaining to SPCB/UPPCB as per the information provided by the consultant.

Schedule of Payment:

5. The payment shall be released as per following schedule:

The Income tax, labour Cess shall be deducted from the bill as per statutory provisions.

6. The rates quoted shall be inclusive of CGST/SGST/IGST or any tax levied by the Central Government in lieu of GST and the same shall be payable by the consultant.

7. The work is required to be completed within time schedule from the date of issue of acceptance letter as given below: -

Total period of completion: The process of submitting online/offline application along with detailed project report shall be completed within a period of 15 days from the date of award of contract. Further all the requisite documents as mentioned in scope of work shall be obtained from SPCB within a period of 60 days from the date of award of work. The RWC Agra may at its discretion, however, on a specific request by the bidder, can extend the time period for the bidder to obtain the specified documents from SPCB.

8. Work shall be awarded to L1 bidder only who has quoted lowest price rate among all qualified/technically accepted consultants.

9. The interested and Eligible Parties/Consultants who are submitting the price rate for the consultancy work are requested to quote their price exclusive of GST. Any tour charges that the consultant/party may charge for their visit including flight/train/road movement and local or outside stay regarding the consultancy work will also be inclusive in the quoted rates and CWC will not be liable to pay any extra charges in the form of fees or hospitality towards the visit of consultants or their representative(s).
