### General Instructions, Terms and Conditions

1. Any EOI received after the scheduled time or incomplete in any manner will not be accepted.
2. The bidder (Individual/firm) is expected to examine all instructions, terms & Conditions, specifications in the EOI form. Failure to furnish information required in every respect will be the Bidders risk and may result into rejection of the bid.
3. Amendment of Bidding Documents:  
At any time prior to the submission of the bids, CWC may, for any reason, whether at their own initiate or in response to the clarification requested by the prospective Bidder, may modify the Bidding Documents by amendments.

The amendment will be notified in writing or by telephone to all prospective Bidders who have received the EOI documents.

4. Signing of Bid  
The bid shall be typed or written in indelible ink and shall be signed by the Bidder or a person or persons duly authorized to bind the Bidder to Contract.
5. Submission of Bid  
The EOI will be required to submit the EOI in two bid system in two separate envelopes as mentioned below:

Envelope No. 1 super-scribed as "Technical Bid" should contain an introductory letter of contractor along with copies of documents as evidences. The Individuals/firms/Service providers have to fill up Annexure "A" with his/her signature along with all supporting documents and samples.

Envelope No. II super/scribed as EOI for Financial Bid and should contain the EOI form duly signed in each page by contractor/authorized signatory along with price bid. The Individual/firm has to fill up Annexure "B".

Both Envelope I & II should be placed in large envelope which should be super- scribed As "EOI for Supply and Dispatch of Wheat from various Godowns in state of Madhya Pradesh to various Rail Goodsheds in the state of Tamilnadu" and addressed to Regional Manager, CWC Regional Office, 75 Arera Hills, Opposite to Kendriya Vidyalaya No. 1, Bhopal – 462011.

6. If the envelope is not sealed and marked, CWC will assume no responsibility for the bid's misplacement or premature opening.
7. Deadline for submission of Bids  
Bids must be received to CWC Regional Office Bhopal at the address specified under commercial bid not later than 11.00 AM on 12/12/2024.

CWC may, at its discretion, extend this deadline for the submission of bids by amending the Bidding Documents in accordance with clause 3, in which case all rights and obligations of CWC and Bidders previously subject to the deadline will thereafter be subject to the deadline as extended.

8. Contacting CWC

No bidder shall contact the CWC on any matter relating to its bids, from the time of bid opening to the time the contract is awarded.

9. Evaluation of Bid

- a) The large envelope (containing separate envelope I & II) will be opened first. Thereafter the envelope I i.e. Technical Bid will be opened.
- b) Those tenderers who have not enclosed Technical Bid documents & not submitted. In such cases their Envelope II which contains the financial bid will not be considered.
- c) The bidders will be pre-qualified in technical bid, who fulfils the following criteria:

- d) The envelope II i.e. Financial Bid will be opened for those parties who submitted Technical Bid.
- e) The contract will be awarded to the L1 bidder in financial bid.
- f) If the price quoted by two or more Individuals/firms/Service Providers are same then the bid will be finalized on the basis of the decision of Regional Manager, CWC Regional Office, Bhopal will be final & binding on all the bidders.

10. Delivery Schedule: Bidder has to ensure to delivered the required quality and quantity of the Wheat within 20 days of issuance of the letter of Award(LOA). The quality, quantity and delivery period should be strictly adhered failing which CWC reserves the right to cancel the order without assigning any reasons whatsoever.

11. The stock of Wheat agreed to supply by the bidder is subject to the quality inspection at the Godowns and the dispatching Railway Goodshed.

12. Bidder has to take comprehensive insurance of the stock identified for the supply and dispatch to destined railway good sheds.

13. The period / validity of the contract may be extended by CWC at its discretion.

14. Bidder has to submit the dispatch plan to the CWC well in advance.

15. Responsibility on Transit losses : The bidder will be responsible for the Transit /Rail Transit losses.

16. Payment

50 % of payment will be made within 07 days of the dispatch of the rakes and remaining 50% of payment will be made within 07 days of receipt of the rakes at concerned railway good shed.

17. CWC reserves the right to reject any or all EOI in full or part thereof without assigning any reason.

18. The Regional Manager, CWC Regional Office, Bhopal is the final authority and his decision will be final and binding on the supplier for any disputes.

19. All legal disputes will have the jurisdiction of Bhopal/Chennai only.

**Specifications of Indian Wheat of all Varieties**

Wheat shall:

- a. Be the dried mature grains of *Triticum vulgare*, *T.compactum*, *T.sphaerococcum*, *T.durum*, *T.aestivum* and *T.dicoccum*.
- b. Have natural size, shape, colour and luster.
- c. Be sweet, clean, wholesome and free from obnoxious smell, discolouration, admixture of deleterious substances including toxic weed seeds and all other impurities except to the extent indicated in the schedule below.
- d. Be in sound merchantable condition.
- e. Not have any admixture of *Argemone Mexicana* and *Lathyrus sativus* (khesari) in any form, coloring matter and any obnoxious, deleterious and toxic material.
- f. Conform to Food Safety and Standards Act/ Rules (formely PFA).
- g. There should be no weevilled and no powder in grains.

Note:

1. Moisture in excess of 12% and upto 14% will be discounted at full value. Stocks containing moisture in excess of 14% are to be rejected.
2. Within the overall limit specified for foreign matter, the poisonous weed seeds shall not exceed 0.4% of which *Dhatura* and *Akra* (*Vicia* species) shall not be more than 0.025% and 0.2% by weight respectively.
3. Kernels with glumes will not be treated as unsound grains during physical analysis, the glumes will be removed and treated as organic foreign matter.
4. Within the overall limit specified for damaged grains, ergot affected grains shall not exceed 0.05%.
