Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. - 6. - Each piece of dunnage pallet (crate) shall be of 1500 mm x 600 mm in size as per IS specification n
 17427:2020 with upto date amendments. Height of pallet shall be minimum 145 mm for stringers plus 35 mm for planks.
- 2. The store shall be of best quality and workmanship confirming to the BIS no. 17427:2020 specifications with up-to-date amendments for **grade 1 non-expandable**.
- 3. The wood shall be reasonably dry such that the shape of the frame may not be altered due to driage of wood subsequently.
- 4. No baton shall have loose or decaying knots as these will endanger structural strength and stability.
- 5. Decayed or infested wood shall not be used
- 6. Nails should be as per the IS specification no. 17427:2020 with upto date amendments.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
