TERMS & CONDITIONS:

1. Works should be executed as per specifications and as per direction of Engineer-in-charge.
2. The "Specifications" shall mean the Specifications attached with the quotation documents and wherever specifications are not available the relevant Central Public Work Department Specification or relevant Bureau of Indian Standard Codes including all amendments upto the date of receipt of quotation shall be applicable.
3. The contractor shall prepare and submit the drawings along with the sizes of the letters, Logos etc and colour combination for approval from the Engineer-in-Charge before manufacturing the LED Sign board.
4. The contractor will have to handover the premises in neat and clean condition and remove from site all debris and all other material and rubbish at his own cost before the work is taken over by the CWC.
5. All T&P required for the work shall be arranged by the contractor at his own cost
6. The electrical equipments/ fixtures should be of ISI marked as specified in quotation or as approved by Engineer-in-Charge.
7. The Contractor has to prepare and install the LED Sign Board fit for all weather conditions. The LED Sign Board would be so designed to withstand heavy wind pressure/ heavy rainfall, hailstorm and other rough weather conditions.
8. The work has to be carried out in neat and tidy manner to the satisfaction of the Engineer-in-Charge and all care has to be taken to ensure that no part of the building and existing infrastructure gets damaged during execution of works. Materials used for carrying out the work shall be as per the prescribed Specification.
9. The rates are inclusive all lead & lifts and GST etc.
10. All taxes like Income Tax etc (Inclusive GST tax) as applicable will be deducted as per Govt. Rule from the Contractor bill.
11. 10% Security Deposit will be deducted from the gross bill amount & will be released after the defect liability period of 12 month which will be reckoned from the date of successful completion of the work. In case any defect is found within the defect liability period, the same shall be repaired by the contractor immediately at his own cost.
12. Contractor will be fully responsible to labour payments, accident, mishappening, damages & other Labour welfare & safety measures.
13. Time allowed for completion of work is **30 days** from the date as to be mentioned in the work order.
14. All payments will be released through e-payments by CWC, RO-Patna.
15. GST or any other tax on input material or services used by contractor in respect of this contract shall be payable by the contractor and Central Warehousing Corporation will not entertain any claim whatsoever in this respect.
16. The rates quoted by the contractor should be inclusive of GST.
17. In the event of any of the documents found fabricated / forged / tampered /altered / manipulated in the NIQ, he would be debarred for participating in CWC – tendering for 5 years.
18. The party to whom the work will be awarded will execute a formal agreement with CWC on a non- judicial stamp paper of appropriate value.
19. In the event of failing to execute the work within quoted rate he would be banned for a period participating of 5 years in CWC future tender / quotation.
20. Copy of self-attested Annexure AA, PAN CARD and GST Registration along with signed Quotation/tender document must be submitted. The bidder who fails to submit the same shall summarily be rejected.
21. The rate quoted will remain valid for 60 days w.e.f date of opening of bid
