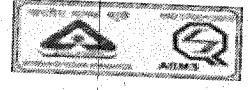



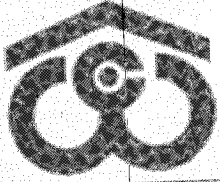

Name of Work: Annual Maintenance contract of Cummins make DG sets of 62.5 & 125 KVA (Non-Comprehensive) at CFS, Kukatpally, Hyderabad.

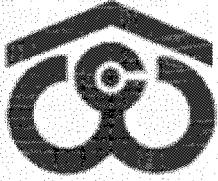
### ELIGIBILITY CRITERIA

The contractor/Firm must have **experience of minimum 2 years**, within a period of last seven years ending MAY-24 in installation, integration, management and maintenance of Cummins make DG sets, in a reputed organization in Private/Public/Government sectors. They should have full technical competence and man power to provide support, regarding **every aspect of the DG set.**

### TERMS AND CONDITIONS

1. The type of contract is Non-Comprehensive.
2. The initial contract period is for 2 years; however, this can be extended for a further period of six months based on the satisfactory performance and at the discretion of the Regional Manager on same rates, terms and conditions which shall be binding on the service provider.
3. The tenderer may quote rates on monthly consolidated basis (exclusive of GST).
4. The contractor/Firm must possess valid GST number and rates to be quoted exclusive of GST.
5. Both Preventive as well as breakdown maintenance is covered under the scope of work, which is non-comprehensive.
6. Income tax or any other statutory deductions shall be made as per Government rule time to time.
7. The tender is not transferable.
8. The contractor may at his own interest, visit the site before quoting.
9. The successful contractor/firm must enter into an agreement with the Corporation on a non-judicial stamp paper of appropriate value within 10 days from the date of issue of work order.
10. The successful contractor/Firm shall furnish interest free security deposit @ 5% of total yearly contract value in the form of DD drawn from a scheduled bank in favour of the Regional Manager, CWC, Hyderabad and payable at Hyderabad. The SD will be released after successful completion of the contract.
11. **Corporation reserve the right to terminate the contract at any time by giving one month notice without assigning any reason whatsoever.**
12. The contractor/firm should engage skilled personnel totally conversant with the equipment for undertaking the maintenance as per annexure-A and scope of work.
13. No tools and plants including ladder shall be issued from CWC stores.
14. The contractor is responsible for the safety of Engineers/Technician/Workmen engaged for the purpose of AMC and during the progress of the work.
15. Nothing under the contract of deployment of personnel shall confer any right by himself or by the contractor/firm to claim any direct employment under ewe or to be treated any time as employee of the Corporation.

16. During the course of the work, contractor should take proper care to avoid any damages to the existing structures. In case of damages, to the existing structures, the contractor at his own cost shall make the same good to the original condition.
17. The offer shall be open for acceptance for **60 days from the date of opening**. The Corporation without prejudice to any right or remedy, be at liberty to forfeit the earnest money, if any quotationer withdrawn his quotation before the date or makes any modification in the terms and conditions of the quotation which are not acceptable to the Corporation. If the quotationer, whose quotation accepted, fails to commence the work specified in the NIQ (along with changes in scope if any) in prescribed time or abandons the work before its completion then the Corporation at its discretion may forfeit the EMD/SD and the decision of CWC in this regard is final and binding on the service provider/contractor. Further the contractor/firm would disqualify for future participating in the tender/quotations of the Corporation for the next five years.
18. The contractor shall quote his rates on the offer sheet and affix his signature on all pages of these documents.
19. The system will be handed over to the contractor in **"as is where is"** condition.
20. The contractor has to hand over the system in good working condition at the end of the contractual period.
21. In case of breakdown of DG set, the service provider will be required to attend to the complaints within 24 hours of complaint being lodged. In case any complaint is not attended to/ rectified within 48 hrs, or in case standby is not provided and the item is not usable beyond 48 hrs, the service provider shall be liable to pay penalty @ ₹200/- (Rupees Two hundred only) Per day.

## 22. Exemption from Submission of EMD:

- I. The bidders/contractors participating under the category of MSEs registered on UDYAM portal are exempted from payment of EMD payable to CWC subject to furnishing the proof of they being so registered under the said portal. The Registration of such bidder/contractor under MSE Notification should be valid as on last date of submission of tender.
- II. Startups certified by Department for Promotion of industry and Internal Trade (DPIIT) are exempted from payment of EMD and should enclose the proof of their being certified with Department for Promotion of Industry and Internal Trade (DPIIT). The certification of such Bidder/contractor by the DPIIT should be valid as on last date of submission of tender.

## 24. Purchase Preference for Micro and Small Enterprise: -

- I. Considering that this is a non-divisible tender, MSEs quoting price within the band of L-1 + 15% will be awarded for full/complete work of tender by bringing down their price to L-1 price in a situation where L-1 Price is from someone other than an MSE.




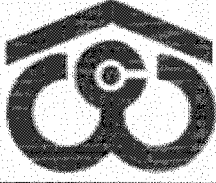
### SCOPE OF WORK

1. The contract is non-comprehensive.
2. The objective of the contract is to keep the Cummins make DG sets of 62.5 & 125 KVA in good working condition 24 x 7, 365 days.
3. The contractor should act proactively and keep the system in good working condition 24 x 7 and prevent any breakdown by providing planned appropriate preventive maintenance.
4. In case of breakdown, at the request of the Manager (CFS), the contractor shall arrange immediately the work force to rectify the defect. He should ensure that the down time is very minimum.
5. The contractor shall provide all consumable.
6. In case of failure of major equipment and needs replacement, the contractor shall give in writing to the Manager (CFS) along with the details of the equipment and cost. The Manager (CFS) will supply the material. Till the supply of the material, the contractor should keep the system in working condition by making temporary arrangement. At any cost, the system should be functional at all time.
7. The scope of the AMC includes both the DG sets of 62.5 & 125 KVA and other hardware that are part of the system as per the equipment list enclosed.
8. The contractor's personnel will be allowed to work on all working days at CFS and on holidays with special permission.
9. All DG set parts should be cleaned once in a month.
10. One fortnight visit is compulsory and during which, the service engineer will ensure the proper functioning of the whole system and certify "Satisfactory functioning of DG set".
11. At present 2 cummin make DG sets of 62.5 & 125 KVA are existing in the CFS. In case any additional DG set(s) is/are added at a later stage, the same also will cover under this AMC and no extra charges will be paid.

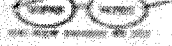
### PAYMENT CONDITIONS
