The category adopted for Security Guard is "SKILLED". Minimum wages will be paid as per the above skill category. The duration of the contract is for 2 years and it will be from start date of services. The minimum wages indicated is as per prevalent rate fixed by the approp riate authority and statutory component (EPF/ESIC/ELDI/PF Admin charge) are fixed as a pe rcentage of minimum wages as per rule in vogue. Salary for the previous month should be paid within 7th day of the succeeding month by the security agency and any delay beyond which penalty will be levied at the rate of Rs. 100/-per day per person. The service provider shall not be allowed to reconstitute the nature of the firm under any circumstances during t he agreement period. - 5. The Seller shall not assign the Contract in whole or part without obtaining the prior writte n consent of buyer.
- 6. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.
- 7. Payment of salaries and wages: Service Provider is required to pay Salaries / wages and all allowances as per mandatory statutory laws for contracted staff deployed at buyer locat ion first i.e. on their own and then claim payment from Buyer along with all statutory documents like, PF, ESIC, Bonus etc. as well as the bank statement of payment done to staff.
- 8. Successful Bidder can submit the Performance Security in the form of e-PBG. After award of contract, Successful Bidder e-PBG and has to ensure delivery of hard copy to the original e-PBG to the Buyer within 15 days of award of contract. The e-PBG should be submitted in the format attahced in exhibits in the ATC document.
- 9. Supplier shall ensure that the invoice raised was in the name of Consignee with GSTIN of Consignee only.
- 10. The bidders exempeted from EMD has to compulsory submit the Bid Security Decleration (Exhibit -6) form as per the exhibits attached in ATC document.
- 11. Bidders are requested to go through the ATC document attahced thoroughly and submit the documents requested as per the Pre-Qualification Criteria and submit the exhibits as prescribed.

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
