The appointed contractor shall remove the bags from the stack inside the godowns, carry them wherever necessary and load the bags on trucks or any other transport vehicle or in the alternative put the bags in a countable position after stacking, the bags etc wherever necessary on platform / ground for purposes of dispatch or for delivery to buyers in accordance with the instructions of the Warehouse Manager or an Officer acting on his behalf. However, while issue of stocks the Contractor shall ensure that their labour / authorized representative shall not demand any 'Dala' / 'bait', failing which the contractor shall be liable for penal action for such corrupt practices / unfair means.
