Contractor who fulfils the following requirements shall be eligible to quote the rate

1. Cost of Tender & Tender Processing Fees:

- Cost of tender to be paid only through e-payment gateway of e procurement system. Proof should be submitted/uploaded with the tender.
- Tender processing fee (Non-refundable) would be paid mandatorily to M/s ITI Ltd. through e-payment on the portal www.cwceprocure.com.

2. Experience Certificate:

Tenderer, during the last four financial years (i.e., 2020-2021, 2021-2022, 2022-23 and 2023-24) & current year (2024-2025) up to the date of tender submission, must have complete successfully the similar nature of work (i.e., **Any Electrical Engineering Works for Building or Roads including supply and erection of cables.**):

- (1) At least **ONE** similar nature of work for Rs. 1,21,267.00 (**80%** of the total amount put on Quotation)

OR

- (2) At least **TWO** similar nature of work for Rs. 1,21,267.00 (**50%** of the total amount put on Quotation)

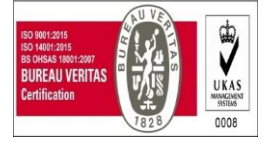
4. PAN Card : Tenderer must enclose copy of PAN Card along with the tender

Terms & Conditions of AMC of DG sets installed at various centre of CWC, offices at Chennai

- 1) Rate should be inclusive of GST as applicable from time to time and the Contractor must be submitted the Invoice / Bill with GSTIN No. (Customer and AMC agency both GSTIN No.)
- 2) Under this AMC the Agency / contractor shall agree to carry out the servicing and maintenance of DG Sets mentioned in the schedule.
At least one visit in every month for service of system is mandatory in each & every centre, and more visit if required at the time of any trouble of system will be done free of cost.
- 3) The maintenance shall constitute preventive maintenance and corrective maintenance of DG Set for proper upkeep for satisfactory functioning.
- 4) The AMC shall be on non-comprehensive basis, which includes service / maintenance; no any extra charge shall be paid to the contractor in this account.
- 5) During visit, the site for carrying out the maintenance of DG Set following checking will be essential.
 - a- Check general condition of the engine, alternator and panel.
 - b- Check the engine safety devices for its working.

- c- Check lube oil pressure, cooling water temperature, lube oil temperature and smoke level are within the limits.
 - d- Check and clean air cleaner element, lube oil filter element, and fuel filter element, lube oil pressure, cooling water temperature, lube oil temperature and smoke level are within the limits.
 - e- Check lube oil condition and change lube oil if required.
 - f- Check the cooling fins of lube oil cooler, cylinder head & liner of air cooled engine and radiator etc.
 - g- Check all the fasteners for its tightness.
 - h- Check fan belt for its tension.
 - i- Check all the rubber hoses for leakage.
 - j- Check the control panel accessories for its working.
 - k- Check the battery charging system and batteries.
 - l- **For checking pollution level in the DG's installed in the Campus as per the ISO standards and submission of the certification as per latest standards. (One time Job only)**
- 6) During AMC period, contractor shall take all reasonable steps to maintain the equipment in proper operating condition.
- 7) Any type of break down or failure in the DG Set, contractor shall send immediately technician to rectify the defects.
- 8) This contract does not cover any overhauling jobs, rewinding jobs, Machining, re conditioning jobs, repairs on starter Motor, Charging Alternator& Radiator, Lube oil/ Engine oil etc which will be charged extra.
