

## Bid Corrigendum

### Buyer Added Bid Specific Additional Terms and Conditions

1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
2. Buyer Added text based ATC clauses
  1. IN REGARDS TO THIS BID PLEASE NOTE THAT THE TERMS & CONDITIONS SET BY THE BUYER SHALL BE FINAL AND ABIDING AND SHALL SUPERSEDE THE GEM GTC AND GEM TERMS & CONDITIONS .
  2. IN REGARDS TO MSE /STARTUP EXEMPTION , EXEPMTION WILL BE GIVEN ONLY FOR TURNOVER , NO EX EMPTION FOR EXPERIENCE
  3. CWC CAN EXERCISE THE RIGHT TO COLLECT ADDITIONAL/CLARIFICATION DOCUMENTS IF ANY REQUIRE D FOR EVALUATION OF TECHNICAL BID. (OTHER THAN MANDATORY DOCUMENTS)
  4. BIDDER NOT SUBMITTING MANDATORY DOCUMENTS WILL BE SUMMARILY REJECTED

2	<b>Specification</b>	The Poly-pallets shall be flat, non-expandable, single deck, general purpose type and confirming to IS 13664: 1993 with up-to-date amendments for Type A pallets. When placed on a horizontal flat surface, the poly-pallets shall rest evenly and the bearing surface shall be flat and horizontal
3	<b>Dimensions</b>	a) Length: 1500 mm $\pm$ 5 mm b) Width: 760 mm $\pm$ 5mm c) Height: 125 mm $\pm$ 5 mm - 0 mm
4	<b>Weight</b>	22 Kgs + 1.5 Kgs - 0 Kg

5	<b>Dimensions &amp; Cross-sectional Details of members</b>	<p>a) Top Member: it shall be made up of a 40 mm x 40 mm hollow section of LDPE reinforced with a 20 mm x 20 mm x 1.0 mm hollow section of steel</p> <p>b) Bottom Member: it shall be made up of solid rail section of LDPE</p> <p>c) Connecting Member: it shall be made up of 20 mm diameter hollow section of LDPE reinforced with a 6mm diameter mild steel bar.</p> <p>d) Spacer: it shall be made up of a 24 mm diameter hollow section of LDPE with a hole diameter of 20 mm to be used as a sleeve on the connecting member for providing equidistant spacing to the bottom members in the assembled Poly-Pallets.</p>

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 20% of total value.

## Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to

exemption provided to such sellers under GeM GTC.

3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
