1. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued

by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents. 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

- 3. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost: or
- 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- a .Tenderer should have experience of Rake Handling and / or Transportation duly obtained from Governm ent Organization or Private Organization dealing in the field of Fertilizer, Foodgrains, Cement, Sugar, Coars e grains or any other commodity. The Tenderer should have successfully completed at least three similar n ature of nature of works, stated above, of value 40 % of the advertised tender value of the work i.e. Rs 46, 39,560 estimated cost of the tender or at least two similar nature of nature of works, stated above, of value 50 % of the advertised tender value of the work i.e. Rs 57,99,450 estimated cost of the tender or at least one similar nature of nature of works, stated above, of value 80 % of the advertised tender value of the work i.e. Rs 92,79,120 estimated cost of the tender during preceding five years and the current year upto dat e of submission of tender.
- b. The Tenderer should have achieved the minimum average turnover **Rs. 34,7 9,670** during the three preceding financial year i.e., not be less than 30% of the estimated annual value of contract.
- c. The Non-MSE tenderers shall make payment of EMD of Rs. 1,15,989/- [1% of

the Estimated value of the contract]. In lieu of EMD, MSEs/Start ups should uplo ad valid UDYAM certificate/ proof of being certified by Department for Promotio n of industry and Internal Trade (DPIIT) along with Bid Security Declaration as p er **Appendix 14** in the letter head.

- d. The documents mentioned at Clause No. 10.2 of MTD are required under mini mum eligibility criteria and are compulsory to participate in the tender process. Non-submission of said mandatory required documents shall make the bid liable to be summarily rejected and no further missing documents shall be called for Minimum Eligibility criteria.
- e. The Regional Manager, Central Warehousing Corporation, Regional Office, Hy derabad at his discretion, extend validity of the tender [tender to remain open f or acceptance] by 30 (Thirty) days and upon written consent received from each of the technically qualified bidders which shall be binding on the tenderers.

- f. The bidder shall be required to comply all the qualification criteria mentioned under the Prequalification criteria. For Experience and Qualifying Criteria bidder s have to submit the solicited documents. All other terms and conditions, requir ements as mentioned in the Additional Qualification documents shall also be complied.
- g. The Contractor shall furnish, **within (15) days** of receiving the Letter of Awa rd/Acceptance Letter from the Corporation, an interest-free Security Deposit as per Clause No.7 of tender document.
- h. This bid is invited using a Custom bid. Bidders may also note that a single rat e in absolute terms for Handling and Transportation has to be quoted. In case, wrong quotes are received, Corporation/ Regional Manager reserves full right to reject such invalid price bids without taking it for further evaluation.
- j. All relevant documents as per MTD [along with Appendices 1 to 15] should be duly digitally signed and uploaded in legible form.

PRICE BID CONDITIONS

BIDDER TO NOTE THAT THE FINANCIAL BID SHOULD BE SUBMITTED SEP ARATELY AND INDEPENDENT OF THE TECHNICAL BID. IN CASE, FINANCI AL BID FORMS PART OF THE TECHNICAL BID, THE BID SHALLBE SUMMA RILY REJECTED BY CWC.

Out of various items mentioned in the Price bid as involved in the Handling and Transportation service, the bidders shall quote one single rate in absolute terms for all the four major operations involved. The four major operations include Cla use XX Part-I 1(b), 2, 3 and 5 with a quantitative rate in absolute terms is of Rs. 57,33,392/-.Total quantitative SOR for Handling and Transportation Services is described as Rs. 57,33,392/-.Price to be quoted at the relevant location in G eM Portal, as per the methodology provided in **Appendix-15** of tender docume nt. This rate shall then be compared with Schedules of Rates (SOR), and percent age increase/decrease shall be worked out and this SOR/ASOR/BSOR shall be made applicable to all the items in Schedule of rates given in the Price Bid.

IN CASES WHERE NON-CONSONANCE OF THE TERMS AND CONDITIONS OF GeMWITH CWC'S, THE CWC'S TERMS SHOULD BE TAKEN INTO COND SIDERATION. FAILING WHICH THE BIDDER SHALL BE DISQUALIFIED WIT HOUT ANY CLARIFICATIONS.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य</u> नियम और शर्तें, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
