# 3. BACKGROUND

- 3.1. Central Warehousing Corporation, a premier Warehousing Agency in India, was established in 1957 for providing logistics support to the agricultural sector and is one of the biggest public warehouse operators in the country offering logistics services to a diverse group of clients. CWC is operating 428 Warehouses across the country with a storage capacity of 11.8 million MT providing warehousing services for a wide range of products ranging from agricultural produce to sophisticated industrial products.
- 3.2. Warehousing activities of Corporation include food grain warehouses, industrial warehousing, custom bonded warehouses, container freight stations, inland clearance depots and air cargo complexes.
- 3.3. Apart from storage and handling, Corporation also offers services in the area of clearing & forwarding, handling & transportations, procurement & distribution, disinfestations services, fumigation services and other ancillary activities.

# 4. PURPOSE OF EXPRESSION OF INTEREST

- 4.1. Central Warehousing Corporation, Corporate Office, New Delhi invites Expression of Interest (EOI) from interested parties for pilot study on implementing AI-based solution through CCTV Surveillance System for warehousing operations.
- 4.2. There has never been a better time to secure one's premises with CCTV Surveillance System; modern innovations have allowed to create high-definition, fully maneuverable, internet-connecting cameras that provide their operators with an even wider range of flexibility than ever before. Regardless of the industry in mind, automation seems to be the next step in their evolution and CCTV Surveillance System is no different.
- 4.3. In the current global scenario, CCTV Surveillance System are being integrated with AI solutions to transform the way operations are being done. From facial recognition to running complex algorithms for determining physical parameters such as temperature, AI is gradually becoming the backbone of smart analytics in all industries, including logistics and supply chain.

- 4.4. Keeping the same in mind and with a vision to supplement the existing CCTV Surveillance System installed at warehouses across PAN India, CWC is looking for a solution which can not only perform transactional analysis, but can also augment the existing security measures by alarming officials of unwanted activity in the warehouse premises. The solution should also monitor the compliances of Standard Operating Procedures during the warehouse operations and should suitably alert the concerned officials in case of any non-compliance.
- 4.5. This document is an Expression of Interest (EOI) for bidders to express their interest for pilot study on implementing AI-based solution through CCTV Surveillance System for warehousing operations. The interested bidders would be required to make presentations of their solution with detail including hardware required, server requirement, software/s license requirement, modules and detailed list of equipment/items with specification & makes required before the Corporation. However, the hardware, software, and other solutions detailed in the presentation should be vendor/OEM neutral, i.e., the presentation should not specify the make and model of the products.
- 4.6. The use cases for video analytics, and other operations (as per scope of work mentioned elsewhere in this document) are also required to be presented. Implementation plan and timelines should also be provided as part of presentation. The date, time and venue for making presentation which is mandatory would be communicated to the eligible bidders after receiving bids from interested bidders.
- 4.7. IT Infrastructure components such as Servers, Databases, Networking & Security components, Storage, Software and other IT components etc. required at the Cloud Data Centre would be provided by Corporation.
- 4.8. The proposed solution of the successful bidder which shall be implemented for the purpose of this pilot shall be evaluated for its effectiveness and compliance to scope of work.

- 5.3 CWC may seek any specific clarifications or missing document(s) to meet the EOI requirement. Irrespective of date of issuance of such document, the document submitted under clarification should be complying with the EOI conditions before last date of publication of bid.
- 5.4 All the responses to the clarifications will be part of the proposal of the respective bidders, and if the clarifications/document(s) are in variance with the earlier information in the

proposal, the information provided in later stages will be the part of the agreement between the successful bidder and CWC.

- 5.5 After the submission of technical bid(s) and presentation(s) to the corporation, the scope of the EOI, along with the timelines for rollout at other warehouses, other terms and conditions, submission of EMD, PBG etc., and Bill of Material would be frozen.
- 5.6 Also, after the submission of documents required in EOI(s) and presentation(s) to the corporation, the turnover of the bidders would be examined for shortlisting (if required) as per guidance notes for selection of implementation agencies published by Ministry of Electronics & Information Technology.
- 5.7 Financial quote will be sought from the eligible bidder(s) in the format and schedule which will be communicated after the submission of technical bid and presentation to the corporation. A compliance certificate would also be taken from the eligible bidders stating compliance of proposed solution w.r.t. the scope of EOI (including revisions to it, if any).
- 5.8 The successful Bidder in the EOI shall carry out the supply, installation, configuration, configuration, commissioning, testing, training and support as per the specifications and the specified scope of work at earmarked location(s) of the corporation mentioned below.

Data processed through CCTV Analytics should be able to generate:

- a) Storage loss /gain with respect to storage period
- b) Quality Analysis Report
- c) Total count and weight of bags received/ issue including made up bags.
- d) Integration with Warehouse Management System of CWC and Depot Online System of FCI.
- e) All other reports pertaining to Gate Movement/Weighbridge operations/ Rake Movement/ Fortnightly operations/ Chemical consumption etc.

- 6.2 Pilot study shall be carried out in Four Godowns (two siding and two non-siding) each at CW Nabha BD and CW Miraj BD. All the prospective bidder/s are encouraged to familiarize themselves with the warehouse location and layout/s thereof for which no expenses will be paid by the corporation.
- 6.3 The proposed solution of the successful bidder which shall be implemented for the purpose of this pilot study shall be evaluated for its effectiveness and compliance to scope of work over a duration of three months. However, duration of the study may be extended, if required.
- 6.4 Further, the distinctive features of the solution, i.e., facial recognition, number plate recognition, counting of bags, determination of bag type, opening and closing of godowns, etc. would be integrated with e-tools of the Corporation, such as HRMS (attendance using facial recognition), Warehouse Management System (truck number, bag type, count of bags etc.), etc.
- 6.5 The project scope will also entail following activities.
  - a) Project Kick off meeting
  - b) Preparation and submission of schedule with list of staff to be deployed under the project during different parts/stages of the project.
  - c) Preparation and submission of schedules of supply, customization, installation, configuration, integration and commissioning
  - d) Supply of software and hardware as per proposed solution
  - e) Customization, installation, configuration, integration and commissioning of proposed solution for carrying out live operations and getting the acceptance of the same from the Corporation.
- 6.6 The proposed solution should be capable of working and integrating with IP wireless CCTV Surveillance System. It should also have event and authorization-based alert systems, wherein, the alerts will be sent only to an authentic person/s and the relevant department.
- 6.7 Al engine should have machine learning capabilities to provide useful actionable insights from live streaming video feed data. The engine should be able to differentiate and analyze the images from video surveillance cameras in order to recognize humans, vehicles, animals or objects.
- 6.8 The successful bidder in the EOI shall carry out the supply, installation, configuration, commissioning, testing, training and support as per the specifications and the specified scope of work at earmarked locations of the corporation mentioned below.
- 6.9 Upon successful completion of the Pilot study, the agency may be asked to rolled out at other warehouses, as per assessment and requirement of CWC.
- 6.10 The proposed solution should be such that the entire control and monitoring can be done remotely through internet connections from control centers established at Regional

Offices/Corporate Office. Also, the remote viewing/live feed of CCTV cameras for all the warehouses is also to be ensured from the time of installation of CCTV cameras.

6.11 The successful bidder and the Corporation would be required to sign a Joint Procedural Order (JPO) after the work is awarded.

- 7.1.
