1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 2. BUYER SPECIFIC TERMS AND CONDITIONS

a. The bidder must submit experience of Rs. 32,84,400/- (35% of the estimated value of the contract) in similar services in successfully and satisfactorily compl

eted single contract in the prescribed format certified by the respective organization.

b. In case of EMD, Rs. 1,87,680/-(2% of the Estimated value of the contract) shall be remitted by the non-MSE tenderers and valid UDYAM certificate and Bid securing declaration in case of MSEs.

c. Successful tenderer shall furnish Security Deposit of 5% of the Estimated Value of Contract within a week of the acceptance of his tender. The Security Deposit amount shall be deposited in favour of the Regional Manager, CWC, Kolkata in the form of Bank Guarantee, issued by scheduled banks.

d. The Tenderer should have achieved the minimum average turnover of Rs. 14,07,600/- during the three preceding financial year. The average turnover of preceding three financial years should not be less than 30% of the estimated annual value of contract.

e. Successful bidder tends to submit 25% of the total estimated value of the contract along with Appendix VIII as BG in instance where the rates quoted in BSO R/Tenderers not having stipulated experience, where the total estimated value of contract for Handling & Transport is less than Rs. 2 (two) crores..

f. The Regional Manager, CWC, RO, Kolkata may at his discretion, extend the ninety (90) days validity to further by Thirty (30) days at the sole discretion of the Regional Manager and upon written consent received by the technically qualified bidders which shall be binding on the tenderers.

g. The bidder shall be required to comply all the qualification criteria mentioned under the Prequalification criteria, Experience and Qualifying Criteria has to submit the solicited documents. All other terms & Conditions, requirements as mentioned in the Additional Qualification documents shall also be complied.

h. This bid is invited using a Custom Bid. The rates for both Handling & Transportation services are invited together. While uploading the technical bid related documents, bidder may exercise his discretion of uploading technical documents in the custom bid. Bidders may also note that a single rate in absolute terms for Handling and Transportation has to be quoted. In case, on receipt of wrong quotes are received, Corporation / Regional Manager reserves full rights to reject such invalid price bids without taking it for further evaluation.

i. The period of contract is for 2 (Two) Years.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
