#### **(A) Mandatory Documents**

Bidder must submit the following:

#### **1. EMD, Cost of Quotation documents & Quotation Processing Fees:**

- a. EMD to be paid in favour of **Regional Manager, Central Warehousing Corporation, Regional Office, Ahmedabad** only through e-payment gateway of e-procurement & receipt of same should be scanned and uploaded on the e-tendering website [www.cwceprocure.com](http://www.cwceprocure.com) along with e-tender documents.
- b. Cost of quotation documents to be paid **only through e-payment gateway of e-procurement system. Proof to be submitted/uploaded with the quotation.**

#### **2. Quotationers/bidders should have followed one of the following criteria to be eligible for bidding :**

- a. Quotationer/bidder must be an enlisted contractor of CPWD / Railways / MES / State PWDs / Other Govt. Organizations / Public Sector Undertakings and their Subsidiaries and hisenlistment is valid for at least one year from the date of tender opening. **OR**
- b. Quotationer must have worked / working with aforesaid Govt. Departments / Agencies during the last four financial years (i.e. 2018-2019, 2019-2020, 2020-21and 2021-2022) & current year (2022 -2023 ) up to the date of ENIQ submission. **OR**
- c. Quotationer or one of his partners is an unemployed Graduate Engineer /Architect passed from Recognized university /Institute in India.

Note: The Bidder will be considered qualified only if **Bidder uploads Copy of Proof** of enlistment/working or Experience/with CPWD/Railways/ MES / State PWDs / Other Govt. Organizations / Public Sector Undertakings and their Subsidiaries or Copy of Degree awarded by Recognized university /Institute in India along with copy of valid Partnership deed or affidavit for sole-propertier firm (Annexure -II)

**Note: It should be noted that credentials for the works executed for Private Organisations shall not be considered.**

#### **3. Undertaking affidavit in the presence of public notary on non judicial stamp paper of Rs. 300/- as per Annexure-I.**

#### **4. ANNEXURE IV**

Bidder shall also submit an affidavit in the presence of public notary on non judicial stamp paper of Rs. 300/as per **ANNEXURE IV** certifying that the documents submitted along with the quotation are under his knowledge and are authentic, genuine, copy of their originals and no part of them is false, forged or fabricated.

**NOTE:- Quotationers not fulfilling the above requirement of mandatory documents or submission of clarification with respect to mandatory documents, shall be summarily rejected.**

#### **(B) Other documents**

##### **5. GST Registration:**

Bidder must have valid GST registration certificate from the concerned authority (as Applicable) and copy to be enclosed with the quotation.

##### **6. PAN Card:** Bidder must enclose copy of PAN card along with the quotation.

##### **7. PF Registration:**

Quotationer must have valid PF Registration certificate from the concerned authority and copy to be enclosed with the E-NIQ..

##### **8. Organization Details:**

In case the bidder is a proprietorship firm, he will submit an undertaking as per **ANNEXURE II**.

In case the bidder is a partnership firm, a certified copy of the partnership deed shall be submitted by the bidder.

In case the bidder is a company (whether Private or public), a certified copy of Certificate of Incorporation together with Memorandum and Article of Association shall be submitted).

Certificate of Registration with Registrars of Company (ROC) in case of Ltd. / Pvt. Ltd. company/PSU, if required shall be submitted by the bidder.

In other cases, certified copy of Certificate of Incorporation shall be submitted by the bidder.

##### **9. Quotationer shall submit a Power of Attorney in favour of signatory(ies) as per ANNEXURE III. This format is for the purpose of guidance only and deviation in the wording can be accepted.**

##### **10. Bank Details:**

The bidder is advised to provide name of bank, account number, branch code and RTGS code for account maintained by them/him for any financial transaction with cancelled cheque.

## **TERMS AND CONDITIONS**

1. Quotationers/bidders should be registered or having worked/ working with CPWD/ Railways/MES/State PWD/ other Govt. Organization/ Public Sector Undertakings & their Subsidiaries.
2. Bidder should upload all the required documents with the quotation under valid digital signature. Uploading of quotation with digital signature shall imply that all quotation terms & conditions are accepted by the bidder.
3. Bidder digital signature on the E- quotation form will be considered as their confirmation that they have read and accepted all the conditions laid down in the quotation documents, unless specific deviation is quoted in the technical bid.
4. E- quotation form is not transferrable and the same is to be submitted with digital signature/signed & scanned copy by the pre- authorized personnel of the bidder. Quotation is to be submitted through e-quotation-mode only at website [www.cwceprocure.com](http://www.cwceprocure.com) along with scanned copies of credential papers.
5. **The quotation without the prescribed earnest money, shall be summarily rejected.**
6. The work shall be executed strictly as per **CPWD** specification/Schedule.
7. Necessary taxes i.e.- income tax & other statutory taxes levied by Govt. time to time will be deducted from the bill as per prevalent rate as on date.
8. The security deposit shall be deducted @ 10% of the gross amount of bill of the contractor which will be refunded after successful completion of defect liability period from date of completion of work. In case any defects are found within defect liability period, the same shall be repaired by the Contractor immediately at his own cost. EMD deposited along with the quotation shall be adjusted against the security deposits to be deducted from the bills of the contractor.
9. Quotationers/bidders shall quote their rates inclusive of GST, as applicable and GST will not be paid/reimbursed by CWC.
10. The contractor shall be required to pay labour cess @1% of cost of construction work in accordance with each bill payable on account of such construction to the concerned State of Govt. (Labour Deptt.) Cost of material shall be outside the purview of cess, when supplied under a separate schedule items. CWC shall not entertain any claim whatsoever in this respect.
11. Quotationer / bidder shall quote their rate inclusive of GST, ESI, EPF, Building & construction workers cess and any other taxes, levies, duties as applicable on complete work, after study the relevant clauses. CWC will not entertain any claim what so ever in this respect. This should be included in the rates quoted by contractor. During the course of the work the contractor should take proper care to avoid any damages to the existing structures. In case of damages to the existing structure the contractor at his/her own cost shall make the same good to the original condition.

12. Contractor will fully responsible to labour payments, accident, mis-happening, damages & other labour welfare & safety measures.
13. Items & Quantities given in the schedule are tentative to give an idea of work involved which may vary as per actual execution at site.
14. Contractor will have to arrange all labour, T&P etc.(at all level) required for the execution/completion of the work as per site condition. Safety of working labour's lies on contractor only at all levels.
15. Time allowed for completion of work shall be **04 Months**.
16. In the event of any of the documents found fabricated/ tempered/ forged/ altered/manipulated/false in the bid even after the award of the contract, it will lead to termination of the contract, forfeiture of EMD available at the time of termination. CWC reserve its rights to disqualify the tenderer and to blacklist/ debar for future participation for the next five years.
17. The offer rate shall be valid for 90 days from the date of opening of bid of quotations.
18. The time for execution of the work specified in the work order shall be deemed to be essence of the contract and the work must be completed within the specified period. If the contractor fails to complete the work within the specified period mentioned in the work order, the Competent Authority may at his discretion extend the date of completion and also consider levy of penalty as deemed fit based on the merit of the case.
19. No advance payment shall be made at any time and payment shall be made only after execution of items/work.
20. The contractor having been given a notice in writing to rectify, reconstruct or replace any defective work or fails to complete the work within the stipulated date or persistently neglects to carry out his obligations under the contract and does not remedy it or take effective steps within **07 days** after the notice, the Engineering-in-Charge shall have power to rescind the contract and the performance guarantee under the contract shall be liable to the forfeited.
21. The Quotation notice and Notice Inviting Quotation shall form the part of contract document.

The successful Quotationer/s shall be required to execute an agreement with CWC in prescribed Proforma at ANNEXURE V within a maximum period of 15 days after date of issue of work order for carrying out the work as per the agreed conditions. **Failure to do so shall constitute a breach, in which case, CWC would be at liberty to not only terminate the contract but also forfeit EMD if any.** The cost of stamp paper for the agreement will be borne by contractor. The contract agreement shall consist of:

The Quotation Notice, Notice Inviting Quotation, Instructions to Quotationers, all the documents of quotation & contract for works including special conditions of contract, technical specifications and drawings, if any, forming the part of quotation documents as

issued/ downloaded by the quotationer from the websites at the time of invitation of quotation and acceptance thereof together with any correspondence with them leading there to and also the correspondence related with verification of credentials.

## 22.0 Insurance for Works persons and property

### 22.1 Insurance for Works

The contractor at the scheduled date of start of work without limiting his obligations and responsibilities, shall insure the works at his own cost and keep them insured until the virtual completion of the contract against all acts of God including Fire, Theft, riots, War, Floods, etc, with a Insurance Agency approved by Insurance Regulatory and Development Authority (IRDA) in the joint names of the employer and Contractor (the name of the former being placed first in the policy) for the full amount of the originally awarded contract value irrespective of revised / modified contract value later on. Such policy shall cover the property of the CWC and fees for assessing the claim and in connection with his services generally therein and shall not cover any property of the Contractor or of any sub contractor.

The Contractor shall deposit the policy and receipt for the premiums with the CWC within 30 days from the date of signing the contract or commencement of execution of work, whichever is earlier, or unless otherwise instructed by the CWC. In default of the Contractor insuring as provided above, the CWC on his behalf may so insure and may deduct the premiums paid from any moneys due or which may become due to the Contractor. The Contractor shall, as soon as any claim under the policy is settled or the works reinstated by the Insurance Office should elect to do so, proceed with all due diligence with the completion of the works in the same manner as though the misfortune/accident had not occurred and in all respects under the same conditions of contract. The Contractor in case of rebuilding or reinstatement after accident shall be entitled to such extension of time for completion as the CWC deems fit.

### 22.2 Insurance in respect of damages to persons and property

- i) The Contractor shall be responsible for all injury to persons, animals or things and for all structural and decorative damage to property which may arise from the operation or neglect of himself or of any approved sub contractor's or Employees, whether such injuries or damage arise from carelessness, accident or any other cause whatsoever in any way connected with carrying out of this contract. The clause shall be held to include any damage to buildings, whether immediately adjacent or otherwise and damage to road, streets footpaths, bridges and works forming the subject of this contract by frost or other inclemency of the weather. The Contractor shall indemnify the CWC and hold him harmless in respect of all and any expenses arising from any such injury or damage to persons or property as aforesaid and in respect of any claims made in respect of injury or damage under any Acts of government or otherwise and also in respect of any award of compensation of damage consequent upon such claims.
- ii) The Contractor shall reinstate all damages of every sort so as to deliver up the whole of the contract works complete and perfect in every respect and so as to make good or otherwise satisfy all claims for damage to the property of third parties.
- iii) The Contractor shall indemnify the CWC against all claims which may be made against the CWC by the member of the public or other third party in respect of works in consequence thereof and shall at his own expense arrange to effect and maintain, until the virtual completion of the contract, **an Insurance Policy with Insurance Agency approved by IRDA in the joint names of the CWC and Contractor against such risks and deposit such policy or policies with the CWC from time to time during the currency of this contract.** The contractor shall similarly indemnify the CWC against all claims which may be made upon the CWC whether

under the Workman's Compensation Act or any other statute in force during the currency of this contract or at common law in respect of any employee of the Contractor or any sub contractor and shall at his own expense effect and maintain with an approved office a policy of insurance in the joint names of the CWC and the Contractor against such risks and deposit such policy or policies with the CWC from time to time during the currency of the Contract. The Contractor shall be responsible for anything which may be excluded from the Insurance policies above referred to and also for all other damage to any property arising out of an incidental to the negligent or defective carrying out of this contract. He shall also indemnify the CWC in respect of any costs, charges or expenses arising out of any claim re-proceedings and also in respect of any award of or compensation of damages arising there from.

- iv) The Employer shall be at liberty and is empowered to deduct the amount of any damage, compensation costs, charges and expenses arising or accruing from or in respect of any such claim or damage of any sum or sums due to or become due to the Contractor including the Security Deposit.
  - v) If the Contractor fails to comply with the terms of these conditions, the Employer may insure the works and may deduct the amount of the premiums paid from any moneys that may be or become payable to the Contractor or may at the option, do not release running payment to the Contractor until the Contractor shall have complied with the terms of this condition.
- 23.0 **ANY OTHER INSURANCE REQUIRED UNDER LAW OR REGULATIONS OR BY CWC.**  
Contractor shall also carry and maintain any other insurance which he may be required under law or regulation from time to time. He shall also carry and maintain any other insurance which may be required by CWC.
- 24.0 **SITE OFFICE**  
Contractor shall have to provide temporary site office with requisite furniture & appliances and godown for storing/stacking construction materials at their own cost for which no extra payment will be made.
- 25.0 **PF COMPLIANCE**  
It will be responsibility of the contractor to obtain separate code/identification No. for contractor's deposit of PF dues, if applicable with concerned authority directly. Copy of PF Registration / code no. alongwith copy of PF paid Challans shall be submitted alongwith Running Account or Final Bill.
- 26.0 **Recoveries/Withhold**
- 26.1 In case of any technical deficiencies, lapses on account of non compliance of PF/ESI, Insurance (WC Policies & CAR policies), labour license, or any other reasons not covered in any clause of tender documents etc., are noticed by the Engineer-in-charge/CWC Vigilance Deptt./ CTE Organization, then a sum as recommended or decided by Project In-charge/ Site Engineer may be withheld, till rectification/remedy/compliance of the deficiencies.
  - 26.2 Recoveries, if any, on account of uncovered period of insurance (WC Policies), defective work, losses to CWC or any other liability not fulfilled by contractor etc., shall be effected from the contractor's bill/any other due (s) amount (i.e. Final Bill, Security Deposit )
- 27.0 **Material obtained from the dismantling:**



The contractors, in the course of their own work, should understand that all materials e.g. stone and other materials obtained in the work of dismantling and excavation etc. will be considered Central Warehousing Corporation's property and would be issued to the contractor (if they require the same for use in the work) at the rates approved by the Engineer-in-Charge, as the case may be.

28. The bidder/s shall not increase his/their rate in case CWC negotiates for reduction of rates. Such negotiations shall not amount to cancellation or withdrawal of original offer and rates originally quoted will be binding on the bidder/s.
29. NOTE:
- (a) CWC (Corporation), if necessary, can ask the bidder for any specific clarification relating to qualifying documents/conditions within the specified time. For this purpose, the procedure stated below is to be followed and the specific clarification is required to be uploaded on the same portal as per the procedure prescribed therein.
  - (b) The bidder has the option to respond or not to respond to these queries.
  - (c) The request for clarification by the Corporation and the response of the bidder shall be in writing and no change in price or substance of the quotation shall be sought, offered or permitted.
  - (d) If the bidder fails to respond, within the stipulated time period or the clarification(s)/document (s) with respect to mandatory documents submitted is non-conforming to requirement of quotation conditions, no further time will be given for submitting the same and the bidder will be summarily rejected.
