NOTICE INVITING QUOTATION

Central Warehousing Corporation (A Govt. of India Undertaking), Regional Office, Delhi invites rate quotations in the sealed envelope from the interested parties for 'By Road Transportation of Import Loaded Containers from JNPT Complex to ICD-Patparganj / Delhi NCR' subject to following terms & conditions: -

- 1. The interested party / bidder shall submit their sealed quotation in the name of Manager, ICD-Patparganj, Central Warehousing Corporation, Near Ghazipur Village, Patparganj, Delhi-110096 between 10:30 Hours to 14:00 Hours 14.10.2024. No quotations shall be accepted after the stipulated time. The sealed quotations shall be opened on 14.10.2024 at 15:00 hours in the office of Manager, ICD-Patparganj. (If the date fixed for submission / opening of tenders is declared holiday, the tenders will be submitted / opened on the next working day following the holiday at the same time).
- 2. The envelope containing rate quotation should be superscribed 'By Road Movement of Import Loaded Container from JNPT Complex to ICD-Patparganj / Delhi NCR'.

4. The Bidders have to quote only rate for **'X'**. The rates for other weight categories will be derived as below:

- **5.** The Weight Slabs are inclusive of weight of Cargo & Container.
- **6.** The above rates are excluding of GST.
- 7. The above rates are inclusive of Toll Tax, NGT Tax or any other taxes levied in transit.
- 8. The successful bidder will work on behalf of CWC and will issue CWC's prescribed Consignment Note at JNPT Complex considering **Central Warehousing Corporation** (CWC) a Goods Transport Agency (GTA).
- **9.** By Road Transportation of Import Loaded Container from JNPT Complex to ICD-Patparganj / Delhi NCR will be purely on the Carrier Bond of concerned SLA / Consolidator / Forwarder / Importer etc. accepted by the appropriate Customs

Authority.

- **10.** In-transit Insurance of Cargo will be the sole responsibility of agency facilitating Carrier Bond for the movement of Import Loaded Container.
- **11.** The agency facilitating Carrier Bond will be responsible for Customs Clearance, relevant documentation including Gate Pass, consolidation & loading of the import goods in the container etc. as the case may be at the JNPT Complex.
- **12.** The interested bidder / party should provide self-attested copies of PAN & GST Registration Certificate with the quotation.
- **13.** The transit time will be 05 days (120 Hours) from the time of issue of Gate Pass to the successful bidder / party from JNPT Complex. After completion of loading in the container and fixing of Customs Seal as the case may be at JNPT Complex, the Gate Pass will be issued by the agency facilitating Carrier Bond for the movement.
- **14.** The successful bidder will intimate CWC regularly & in time interval by email / messages regarding the progress of operation / movement.
- **15.** For delay in movement, a penalty will be deducted from the successful bidder / party
 - for 1 day (24 hrs) -25% of quoted rate (or part thereof)
 - for 2 days (48 hrs) -50% of quoted rate (or part thereof)
 - for 3 days-(72 hrs) 100% of quoted rate (or part thereof)

The duration of day will be considered 24 hrs commencing from the time of issue of Gate Pass to the successful bidder / party. Any force majeure event will be considered on case-to-case basis based on the substantiating documentary evidence and representation of the transporter. The Regional Manager, Central Warehousing Corporation, Regional Office, Delhi will be the sole authority to decide the quantum of penalty.

- **16.** The successful party / bidder will have to carry the Import Loaded Container in safe & good condition with intact Customs Seal as mentioned in the document.
- **17.** There will be no minimum assured guarantee volume.
- **18.** This arrangement will be valid for a period of 03 Months (Three Months) from the date of issue of award of work by CWC which is extendable for a further period of 03 Months (Three Months) on mutually agreed terms & conditions by both the parties.
- **19.** Escalation in rates will not be allowed during the agreed period.
- **20.** The successful bidder / party will have to provide an Indemnity Bond for an amount of Rs.10,00,00,000/- (Rupees Ten Crores only) to safeguard the interests of CWC, within 07 working days from the date of issue of award of work.
- **21.** In case of differences in quoted rates in figure & words, the lower rate shall be accepted for the purpose of the evaluation of the bid.
- **22.** Activities / conditions which are not specifically covered in this quotation, will be dealt mutually by both the parties.
- **23.** The Regional Manager, Central Warehousing Corporation, Regional Office, Delhi for and on behalf of the CWC reserves the right to reject any or all the quotations without assigning any reasons thereof and does not bind himself to accept the lowest or any other quotation. The successful bidder shall execute the agreement, preceded by furnishing an Indemnity Bond within the prescribe period.

- **24.** The conditional quotations will be summarily rejected.
- **25.** The bidder while submitting the quotation would be deemed to have read and understood all the conditions of the quotation which will be binding on him.
- **26.** The bidder has to provide relevant documents establishing the fact that they are Partnership / Sole Proprietary Company i.e. Partnership Deed / Certificate of Incorporation / Memorandum of Association / Article of Association.
- **27.** The CWC reserve the right to invite only L-1 bidder for negotiation / clarification by the Regional Manager, Central Warehousing Corporation, Regional Office, Delhi.
- **28.** Person or persons signing the quotation shall state in what capacity he or she or they are signing the quotation e.g. as Sole Proprietor of a firm or as a Partner of a Partnership Firm or as a Secretary / Manager / Director etc. of a body corporate.
- **29.** CWC reserves the right to relax the conditions of the quotation at any stage if considered necessary for the purpose of finalizing the contract in the overall interest of the CWC and the trade.
- **30.** The successful bidder will bill to CWC on monthly basis and all payments due to successful bidder for services rendered against this contract shall be made by cheque / electronic mode within **30 (Thirty) days** from the date of submission of bills after scrutiny, if found to be in order. The payment will be made after statutory deduction and any other dues as applicable at source.
- **31.** During the currency of the contract, if the services of the successful bidder are not found to be satisfactory, CWC reserves the right to terminate the contract with 15 (Fifteen) Days prior notice without payment of any compensation or whatsoever.
