- 1. The interested party / bidder shall submit their sealed quotation in the name of Manager, ICD-Patparganj, Central Warehousing Corporation, Near Ghazipur Village, Patparganj, Delhi-110096 between 10:30 Hours to 17:00 Hours on working days on or before 24.12.2024. No quotations shall be accepted after the stipulated time. The sealed quotations will be opened on 26.12.2024 at 15:00 hours in the office of Manager, ICD-Patparganj. (If the date fixed for submission / opening of tenders is declared holiday, the tenders will be submitted / opened on the next working day following the holiday at the same time).
- 2. The envelope containing rate quotation should be superscribed with 'Service Provider for Repair, Washing & Cleaning of ISO Containers at ICD-Patparganj'.
- **3.** The interested party / bidder shall submit their rate towards Facility Charges in the following format:

- **4.** The successful bidder will pay the Facility Charges to CWC on monthly basis on or before of 7<sup>th</sup> of each month.
- **5.** The party / bidders quoted highest Facility Charges will be considered as Successful Bidder.
- **6.** The rates mentioned in this NIQ are excluding of GST and/or other taxes as applicable and will be collected from the bidder accordingly.
- 7. The successful bidder will be allotted minimum open area of 20 Square Meter at ICD-Patparganj for storage of their equipment & machinery and charges as per applicable tariff will be collected at the beginning of each month.

- **8.** The successful bidder shall pay the legitimate charges / dues to CWC within a period of 04 (Four) working days from the date of issue of Invoice / Bill / Demand Note by CWC failing which, interest @18% per annum will be charged.
- **9.** In case of differences in quoted rates in figure & words, the higher rate shall be accepted for the purpose of the evaluation of the bid.
- **10.** There will be no minimum assured guarantee volume.
- **11.** Activities / conditions which are not specifically covered in this quotation, will be dealt mutually by both the parties.
- **12.** The area allotted to the successful bidder may be increased in future as per the demand of the bidder considering volume of the work.
- **13.** The successful bidder shall arrange sufficient Insurance Policy for their man & materials against any loss or damage or theft or pilferage etc. at ICD-Patparganj. CWC shall not be responsible for any such incidences.
- 14. The successful bidder shall pay Electricity Charges on actual consumption basis, at tariff for the highest slab to be determined by Sub-Meter, to be installed at their own cost. The successful bidder shall ensure that the consumption of Electricity Charges do not exceed the sanctioned load of unit and in case, additional load is required, the same will be arranged at their cost.
- **15.** The successful bidder shall arrange water required for washing/cleaning/repair of container at their own. CWC shall not be responsible to arrange any water for this purpose.
- **16.** The successful bidder shall provide self-attested copies of PAN, GST Registration Certificate, Bank Detail and/or any other information / documents as sought by CWC.
- 17. This arrangement will be valid for a period of 03 Months (Three Months) from the date of issue of award of work by CWC which is extendable for a further period of 03 Months (Three Months) on mutually agreed terms & conditions by both the parties.
- **18.** The conditional quotations will be summarily rejected.
- **19.** The bidder while submitting the quotation would be deemed to have read and understood all the conditions of the quotation which will be binding on him.

- **20.** The Regional Manager, Central Warehousing Corporation, Regional Office, Delhi for and on behalf of the CWC reserves the right to reject any or all the quotations without assigning any reasons thereof and does not bind himself to accept the highest or any other quotation. The successful bidder shall execute an agreement within the prescribe period.
- **21.** The CWC reserve the right to invite only H-1 bidder for negotiation / clarification by the Regional Manager, Central Warehousing Corporation, Regional Office, Delhi.
- **22.** CWC reserves the right to relax the conditions of the quotation at any stage if considered necessary for the purpose of finalizing the contract in the overall interest of the CWC and the trade.
- 23. The successful bidder shall deploy efficient skilled manpower for repairs, cleaning & washing of the containers who will be equipped with the necessary safety equipment's, dresses commensurate to the safety norms for such jobs. The Service Provider to indemnify the CWC against all claims, demands, made against and / or loss caused and / or damages, suffered and / or cost, charges / expenses incurred to and / or penalty levied and / or any claim due to injury to or death of any person and / or loss or damage caused or suffered to property owned or belonging to the CWC including containers assigned for such facilities.
- **24.** The successful bidder will ensure to carry on their operations in the allotted space under the overall discipline of CWC and shall also abide by various laws in force. The successful bidder will also assume the responsibility for any damages to the property due to their negligence while the same remains under their occupation & use.
- 25. CWC agrees to allow the successful bidder to carry out their operation round the clock on all working days. In case the successful bidder is required to work on holidays, they would be required to give advance intimation to Manager, ICD-Patparganj including compliance of prescribed procedure as laid down by CWC.
- **26.** During the currency of the contract, if the services of the successful bidder are not found to be satisfactory, CWC reserves the right to terminate the contract with 15 (Fifteen) Days prior notice without payment of any compensation or whatsoever.
